

1 AN ACT concerning education.

2 Be it enacted by the People of the State of Illinois,
3 represented in the General Assembly:

4 Section 5. The School Code is amended by adding Sections
5 10-20.37 and 34-18.26 as follows:

6 (105 ILCS 5/10-20.37 new)

7 Sec. 10-20.37. Provision of student information
8 prohibited. A school district may not provide a student's
9 name, address, telephone number, social security number,
10 e-mail address, or other personal identifying information to
11 a business organization or financial institution that issues
12 credit or debit cards.

13 (105 ILCS 5/34-18.26 new)

14 Sec. 34-18.26. Provision of student information
15 prohibited. The school district may not provide a student's
16 name, address, telephone number, social security number,
17 e-mail address, or other personal identifying information to
18 a business organization or financial institution that issues
19 credit or debit cards.

20 Section 10. The University of Illinois Act is amended by
21 adding Section 30 as follows:

22 (110 ILCS 305/30 new)

23 Sec. 30. Provision of student information prohibited.
24 The University may not provide a student's name, address,
25 telephone number, social security number, e-mail address, or
26 other personal identifying information to a business
27 organization or financial institution that issues credit or
28 debit cards.

1 Section 15. The Southern Illinois University Management
2 Act is amended by adding Section 15 as follows:

3 (110 ILCS 520/15 new)

4 Sec. 15. Provision of student information prohibited.
5 The University may not provide a student's name, address,
6 telephone number, social security number, e-mail address, or
7 other personal identifying information to a business
8 organization or financial institution that issues credit or
9 debit cards.

10 Section 20. The Chicago State University Law is amended
11 by adding Section 5-120 as follows:

12 (110 ILCS 660/5-120 new)

13 Sec. 5-120. Provision of student information prohibited.
14 The University may not provide a student's name, address,
15 telephone number, social security number, e-mail address, or
16 other personal identifying information to a business
17 organization or financial institution that issues credit or
18 debit cards.

19 Section 25. The Eastern Illinois University Law is
20 amended by adding Section 10-120 as follows:

21 (110 ILCS 665/10-120 new)

22 Sec. 10-120. Provision of student information
23 prohibited. The University may not provide a student's name,
24 address, telephone number, social security number, e-mail
25 address, or other personal identifying information to a
26 business organization or financial institution that issues
27 credit or debit cards.

28 Section 30. The Governors State University Law is

1 amended by adding Section 15-120 as follows:

2 (110 ILCS 670/15-120 new)

3 Sec. 15-120. Provision of student information
4 prohibited. The University may not provide a student's name,
5 address, telephone number, social security number, e-mail
6 address, or other personal identifying information to a
7 business organization or financial institution that issues
8 credit or debit cards.

9 Section 35. The Illinois State University Law is amended
10 by adding Section 20-125 as follows:

11 (110 ILCS 675/20-125 new)

12 Sec. 20-125. Provision of student information
13 prohibited. The University may not provide a student's name,
14 address, telephone number, social security number, e-mail
15 address, or other personal identifying information to a
16 business organization or financial institution that issues
17 credit or debit cards.

18 Section 40. The Northeastern Illinois University Law is
19 amended by adding Section 25-120 as follows:

20 (110 ILCS 680/25-120 new)

21 Sec. 25-120. Provision of student information
22 prohibited. The University may not provide a student's name,
23 address, telephone number, social security number, e-mail
24 address, or other personal identifying information to a
25 business organization or financial institution that issues
26 credit or debit cards.

27 Section 45. The Northern Illinois University Law is
28 amended by adding Section 30-130 as follows:

1 (110 ILCS 685/30-130 new)
 2 Sec. 30-130. Provision of student information
 3 prohibited. The University may not provide a student's name,
 4 address, telephone number, social security number, e-mail
 5 address, or other personal identifying information to a
 6 business organization or financial institution that issues
 7 credit or debit cards.

8 Section 50. The Western Illinois University Law is
 9 amended by adding Section 35-125 as follows:

10 (110 ILCS 690/35-125 new)
 11 Sec. 35-125. Provision of student information
 12 prohibited. The University may not provide a student's name,
 13 address, telephone number, social security number, e-mail
 14 address, or other personal identifying information to a
 15 business organization or financial institution that issues
 16 credit or debit cards.

17 Section 55. The Public Community College Act is amended
 18 by adding Section 3-60 as follows:

19 (110 ILCS 805/3-60 new)
 20 Sec. 3-60. Provision of student information prohibited.
 21 A community college may not provide a student's name,
 22 address, telephone number, social security number, e-mail
 23 address, or other personal identifying information to a
 24 business organization or financial institution that issues
 25 credit or debit cards.

26 Section 99. Effective date. This Act takes effect on
 27 July 1, 2003.
