AN ACT concerning civil liabilities.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Wrongful Death Act is amended by changing
Section 2.1 as follows:

6 (740 ILCS 180/2.1) (from Ch. 70, par. 2.1)

Sec. 2.1. If In the event that the only asset of the 7 deceased estate is a cause of action arising under this Act, 8 and no petition for letters of office for his or her estate has 9 10 been filed, the court, upon motion of any person who would be entitled to a recovery under this Act, and after such notice to 11 the party's heirs or legatees as the court directs, and without 12 opening of an estate, may appoint a special administrator for 13 14 the deceased party for the purpose of prosecuting or defending 15 the action. If there is more than one special administrator appointed and one of the administrators is a corporation 16 17 qualified to act as a representative of the estate of a 18 decedent and if the compensation of the attorney or attorneys 19 representing the special administrators is solely determined 20 under a contingent fee arrangement, then upon petition and approval by the court, the special administrator which is a 21 22 corporation shall not participate in or have any duty to review 23 the prosecution of the action, to participate in or review the appropriateness of any settlement of the action, or 24 to in or review 25 determination of participate any the 26 appropriateness of any fees awarded to the attorney or attorneys employed in the prosecution of the action. 27

If a judgment is entered or the action is settled in favor of the special administrator, he or she shall distribute the proceeds as provided by law, except that if proceeds in excess of \$5,000 are distributable to a minor or person under legal disability, the court shall allow disbursements and fees to the HB5293 - 2 - LRB093 17102 LCB 42768 b

special administrator and his or her attorney and the balance shall be administered and distributed under the supervision of the probate division of the court if the circuit court has a probate division.
