Be it enacted by the People of the State of Illinois, represented in the General Assembly:

ARTICLE 1

Section 5. - 19 Section 20. The amount of \$380,000, or so much thereof
- 20 as may be necessary, is appropriated from the General Revenue
- 21 Fund to the Illinois Arts Council for grants to certain
- 22 public radio and television stations for operating costs.
- 23 Section 25. The amount of \$4,904,200, or so much thereof
- 24 as may be necessary is appropriated from the General Revenue
- 25 Fund to the Illinois Arts Council for grants to certain
- 26 public radio and television stations and related
- 27 administrative expenses, pursuant to the Public Radio and
- 28 Television Grant Act.
- 29 Section 99. Effective date. This Act takes effect on July 1,
- 30 2004.
