- 8 WHEREAS, He graduated from St. John's Military Academy in 9 Wisconsin in 1965, and later earned a Bachelor of Arts degree 10 in 1969 from the University of Dubuque in Iowa; and
- 11 WHEREAS, Rick began his professional career as an owner and
  12 operator of Carney Custom Decorating, he then became a partner
  13 of Platinum Venture Partners I and II, and then was an
  14 Arbitrator in the 18th Judicial Circuit Court; and
- 15 WHEREAS, He has served as the County Recorder for five straight terms beginning in 1984; in his first term as 16 Recorder, he oversaw the complete computerization of the 17 Recorder's Office; in his second term, he implemented a 18 state-of-the-art optical imaging system for all documents, 19 20 bringing the records management of the Recorder's Office to the leading edge of technology; this innovation has been recognized 21 22 in several magazines and newspaper publications; and
  - WHEREAS, He completed the computer link between the DuPage County Recorder and the Cook County Recorder that allows the research of information from either county location; this is the first system of its kind within the United States whereby two counties have interchangeable information; and
- WHEREAS, He served as a member of Illinois Attorney General
  Jim Ryan's Commission on Electronic Commerce and Crime which

- developed the Electronic Commerce Security Act; and
- WHEREAS, Rick bravely served his country in the U.S. Army
- 3 from 1969 to 1975; and
- WHEREAS, He is a member of countless professional and civic
- 5 organizations, including Founder and Chairman of the United
- 6 States Association of Recorders, Illinois Association of
- 7 Recorders and Clerks, Founder of Illinois Elected Recorders
- 8 Conference, National Association of County Officials,
- 9 International Association of Recorders and Clerks, DuPage
- 10 County Computerization Committee, St. John's Northwestern
- 11 Military Academy Board of Trustees, Illinois Arts Council
- 12 Foundation Board Member, YMCA DuPage Club Board of Directors,
