SYNOPSIS AS INTRODUCED:

20 ILCS 4040/10

Amends the Social Security Number Protection Task Force Act. Provides for the appointment of an additional member to the Task Force to represent the Illinois courts. Requires the Task Force to present its findings to the General Assembly no later than March 1, 2006 (now, required the first day of the 2004 fall veto session). Effective immediately.

1 AN ACT concerning State government.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 Section 5. The Social Security Number Protection Task Force
5 Act is amended by changing Section 10 as follows:

6 (20 ILCS 4040/10)

7 Sec. 10. Social Security Number Protection Task Force.

8 (a) The Social Security Number Protection Task Force is
9 created. The Task Force shall consist of the following members:

10 (1) One member representing the House of
11 Representatives, appointed by the Speaker of the House of
12 Representatives;

13 (2) One member representing the House of
14 Representatives, appointed by the Minority Leader of the
15 House of Representatives;

16 (3) One member representing the Senate, appointed by
17 the President of the Senate;

18 (4) One member representing the Senate, appointed by
19 the Minority Leader of the Senate;

20 (5) One member representing the Office of the Attorney
21 General, appointed by the Attorney General;

22 (6) One member representing the Office of the Secretary
23 of State, appointed by the Secretary of State;

24 (7) One member representing the Office of the Governor,
25 appointed by the Governor;

26 (8) One member representing the Department of Natural
27 Resources, appointed by the Director of Natural Resources;

28 (9) One member representing the Department of Public
29 Aid, appointed by the Director of Public Aid;

30 (10) One member representing the Department of
31 Revenue, appointed by the Director of Revenue;

32 (11) One member representing the Department of State

1 Police, appointed by the Director of State Police; ~~and~~

2 (12) One member representing the Department of
3 Employment Security, appointed by the Director of
4 Employment Security; and

5 (13) One member representing the Illinois Courts,
6 appointed by the Director of the Administrative Office of
7 Illinois Courts.

8 (b) The Task Force shall examine the procedures used by the
9 State to protect an individual against the unauthorized
10 disclosure of his or her social security number when the State
11 requires the individual to provide his or her social security
12 number to an officer or agency of the State.

13 (c) The Task Force shall report its findings and
14 recommendations to the Governor, the Attorney General, the
15 Secretary of State, and the General Assembly no later than
16 March 1, 2006 ~~the first day of the 2004 fall veto session of~~
17 ~~the 93rd General Assembly.~~
