AN ACT concerning State government.

## 2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

4 Section 5. The Department of Public Health Powers and 5 Duties Law of the Civil Administrative Code of Illinois is 6 amended by adding Section 2310-403 as follows:

7 (20 ILCS 2310/2310-403 new)

8 <u>Sec. 2310-403. Sarcoidosis Research Fund. To make grants</u> 9 <u>for sarcoidosis research from appropriations to the Department</u> 10 from the Sarcoidosis Research Fund.

Section 10. The State Finance Act is amended by adding Section 5.640 as follows:

13 (30 ILCS 105/5.640 new)

14 <u>Sec. 5.640. The Sarcoidosis Research Fund.</u>

15 Section 15. The Illinois Income Tax Act is amended by 16 changing Sections 509 and 510 and by adding Section 507EE as 17 follows:

18 (35 ILCS 5/507EE new)

Sec. 507EE. Sarcoidosis Research Fund checkoff. The 19 Department shall print on its standard individual income tax 20 form a provision indicating that if the taxpayer wishes to 21 22 contribute to the Sarcoidosis Research Fund, as authorized by this amendatory Act of the 94th General Assembly, he or she may 23 24 do so by stating the amount of the contribution (not less than \$1) on the return and that the contribution will reduce the 25 26 taxpayer's refund or increase the amount of payment to accompany the return. Failure to remit any amount of increased 27 payment shall reduce the contribution accordingly. This 28

3 Sec. 509. Tax checkoff explanations. All individual income 4 tax return forms shall contain appropriate explanations and 5 spaces to enable the taxpayers to designate contributions to the following funds: the Child Abuse Prevention Fund, the 6 7 Illinois Wildlife Preservation Fund (as required by the Illinois Non-Game Wildlife Protection Act), the Alzheimer's 8 9 Disease Research Fund (as required by the Alzheimer's Disease 10 Research Act), the Assistance to the Homeless Fund (as required 11 by this Act), the Penny Severns Breast and Cervical Cancer Research Fund, the National World War II Memorial Fund, the 12 Prostate Cancer Research Fund, the Lou Gehrig's Disease (ALS) 13 14 Research Fund, the Multiple Sclerosis Assistance Fund, the 15 Sarcoidosis Research Fund, the Leukemia Treatment and 16 Education Fund, the World War II Illinois Veterans Memorial Fund, the Korean War Veterans National Museum and Library Fund, 17 18 the Illinois Military Family Relief Fund, the Illinois Veterans' Homes Fund, and the Asthma and Lung Research Fund. 19

Each form shall contain a statement that the contributions will reduce the taxpayer's refund or increase the amount of payment to accompany the return. Failure to remit any amount of increased payment shall reduce the contribution accordingly.

If, on October 1 of any year, the total contributions to any one of the funds made under this Section do not equal \$100,000 or more, the explanations and spaces for designating contributions to the fund shall be removed from the individual income tax return forms for the following and all subsequent years and all subsequent contributions to the fund shall be refunded to the taxpayer.

2 Sec. 510. Determination of amounts contributed. The 3 Department shall determine the total amount contributed to each 4 of the following: the Child Abuse Prevention Fund, the Illinois 5 Wildlife Preservation Fund, the Assistance to the Homeless 6 Fund, the Alzheimer's Disease Research Fund, the Penny Severns Breast and Cervical Cancer Research Fund, the National World 7 8 War II Memorial Fund, the Prostate Cancer Research Fund, the 9 Illinois Military Family Relief Fund, the Lou Gehrig's Disease (ALS) Research Fund, the Multiple Sclerosis Assistance Fund, 10 the Sarcoidosis Research Fund, the Leukemia Treatment and 11 Education Fund, the World War II Illinois Veterans Memorial 12 13 Fund, the Korean War Veterans National Museum and Library Fund, the Illinois Veterans' Homes Fund, and the Asthma and Lung 14 15 Research Fund; and shall notify the State Comptroller and the 16 State Treasurer of the amounts to be transferred from the 17 General Revenue Fund to each fund, and upon receipt of such notification the State Treasurer and Comptroller shall 18 19 transfer the amounts.
