Makes appropriations and reappropriations to the Board of Trustees of Southern Illinois University for various purposes. Effective July 1, 2005.

A BILL FOR

1 AN ACT making appropriations and reappropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 Section 5. The following amounts, or so much of those
5 amounts as may be necessary, are appropriated from the
6 General Revenue Fund to the Board of Trustees of Southern
7 Illinois University for the objects and purposes specified,
8 for the fiscal year ending June 30, 2006:

22 Section 10. The sum of \$800,000, or so much thereof as
23 may be necessary and remains unexpended at the close of
24 business on June 30, 2005, from a reappropriation heretofore
25 made for such purpose in Article 109, Section 20 of Public
26 Act 93-842, is reappropriated from the Capital Development
27 Fund to the Board of Trustees of Southern Illinois University
28 to purchase equipment for Altgeld Hall and the Old Baptist
29 Foundation Building. This appropriation is in addition to
30 any funds previously appropriated.

1 Section 15. The sum of \$2,906,400, or so much thereof as
2 may be necessary, is appropriated from the Capital
3 Development Fund to the Board of Trustees of Southern
4 Illinois University for the planning of the construction and
5 renovation of the Science Laboratory Building at Southern
6 Illinois University at Edwardsville.

7 Section 20. The sum of \$3,902,900, or so much thereof as
8 may be necessary, is appropriated from the Capital
9 Development Fund to the Board of Trustees of Southern
10 Illinois University for the planning of the construction of
11 the Transportation and Education Center at Southern Illinois
12 University at Carbondale.

13 Section 99. Effective date. This Act takes effect July 1,
14 2005.
