2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 Section 5. The Metropolitan Water Reclamation District Act  
5 is amended by adding Section 301 as follows:

6 (70 ILCS 2605/301 new)

7 Sec. 301. District enlarged. Upon the effective date of  
8 this amendatory Act of the 94th General Assembly, the corporate  
9 limits of the Metropolitan Water Reclamation District are  
10 extended to include within those limits the following described  
11 tract of land and the tract is annexed to the District.

12 THE PARCEL THAT IS DESCRIBED AS THE EXCEPTION IN "TRINITY  
13 CREEKS, PHASE ONE," A SUBDIVISION OF PART OF THE NORTHEAST  
14 1/4 OF SECTION 20, TOWNSHIP 35 NORTH, RANGE 13 EAST OF THE  
15 THIRD PRINCIPAL MERIDIAN IN COOK COUNTY, ILLINOIS THAT WAS  
16 RECORDED ON 13 JANUARY 2005 AS DOCUMENT 05 01339042 THAT IS  
17 SPECIFICALLY DESCRIBED AS FOLLOWS:

18 BEGINNING AT THE INTERSECTION OF THE NORTH AND WEST  
19 LINES OF THE SOUTHWEST 1/4 OF THE NORTHEAST 1/4 OF SAID  
20 SECTION 20, TOWNSHIP 35 NORTH, RANGE 13 EAST OF THE THIRD  
21 PRINCIPAL MERIDIAN, THENCE SOUTH 89 DEGREES 40 MINUTES 24  
22 SECONDS EAST ALONG SAID NORTH LINE OF THE SOUTHWEST 1/4 OF  
23 THE NORTHEAST 1/4 A DISTANCE OF 168.00 FEET, THENCE SOUTH 0  
24 DEGREES 4 MINUTES 46 SECONDS EAST 26.11 FEET, THENCE NORTH  
25 89 DEGREES 44 MINUTES 31 SECONDS WEST A DISTANCE OF 168.00  
26 FEET TO SAID WEST LINE OF THE NORTHEAST 1/4 OF SECTION 20,  
27 TOWNSHIP 35 NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL  
28 MERIDIAN, THENCE NORTH 0 DEGREES 4 MINUTES 46 SECONDS WEST  
29 ALONG THE LAST DESCRIBED LINE A DISTANCE OF 26.31 FEET TO  
30 THE POINT OF BEGINNING, ALL IN COOK COUNTY, ILLINOIS.
