

94TH GENERAL ASSEMBLY State of Illinois 2005 and 2006 HB4650

Introduced 1/12/2006, by Rep. Jack D. Franks

SYNOPSIS AS INTRODUCED:

60 ILCS 1/30-130

Amends the Township Code. Changes the definition of inoperable vehicle to include certain motor vehicles that are incapable of being lawfully driven on the highway under their own motor power (now, includes certain motor vehicle that are incapable of being driven under their own motor power). Provides that the definition of inoperable vehicle includes abandoned, discarded, dismantled, and unlicensed vehicles.

1 AN ACT concerning local government.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Township Code is amended by changing Section 30-130 as follows:

- 7 Sec. 30-130. Inoperable motor vehicles.
 - (a) The electors may by ordinance declare inoperable motor vehicles, whether on public or private property, to be a nuisance and may authorize fines to be levied for the failure of any person to obey a notice from the township stating that the person is to dispose of any inoperable motor vehicles under his or her control. The electors may authorize a law enforcement agency with applicable jurisdiction to remove, after 7 days from the issuance of the township notice, any inoperable motor vehicle or parts of such a vehicle.
 - (b) Nothing in this Section applies to any motor vehicle that is kept within a building when not in use, to an operable historic vehicle over 25 years of age, or to a motor vehicle on the premises of a place of business engaged in the wrecking or junking of motor vehicles.
- (c) As used in this Section, "inoperable motor vehicle" 22 23 means any motor vehicle from which, for a period of at least 7 days or any longer period of time fixed by ordinance, the 24 25 engine, wheels, or other parts have been removed, or on which 26 the engine, wheels, or other parts have been altered, damaged, 27 or otherwise treated so that the vehicle is incapable of being 28 lawfully driven under its own motor power on the highway in full accordance with the State of Illinois Vehicle Code. The 29 30 definition of "inoperable vehicle" includes abandoned, discarded, dismantled, and unlicensed vehicles. "Inoperable 31 32 motor vehicle" does not include a motor vehicle that has been

- 1 rendered temporarily incapable of being driven under its own
- 2 motor power in order to perform ordinary service or repair
- 3 operations.
