27 WHEREAS, Mr. Alexander received the Principal of Excellence Award in 1995 and the Outstanding Principal 28 29 Leadership Award in 1998; he is a member of the Chicago Principals and Administrators Association, the NAACP, Phi 30 Delta Kappa Education Fraternity, NASSP, and the Association 31 for Supervision and Curriculum Development; and 32
