SYNOPSIS AS INTRODUCED:

415 ILCS 5/12.5

Amends the Environmental Protection Act. Provides that the annual fees applicable to discharges under NPDES permits do not apply to (i) a unit of local government, (ii) a private sector contractor providing sewage treatment services or infrastructure under contract with the State, any department or agency of the State, a unit of local government, or a school district during the course of providing those services, or (iii) a not-for-profit organization. Effective July 1, 2005.

AN ACT concerning environmental protection.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Environmental Protection Act is amended by
changing Section 12.5 as follows:

Sec. 12.5. NPDES discharge fees; sludge permit fees.

(a) Beginning July 1, 2003, the Agency shall assess and 8 collect annual fees (i) in the amounts set forth in subsection 9 (e) for all discharges that require an NPDES permit under 10 subsection (f) of Section 12, from each person holding an NPDES 11 permit authorizing those discharges (including a person who 12 13 continues to discharge under an expired permit pending 14 renewal), and (ii) in the amounts set forth in subsection (f) 15 of this Section for all activities that require a permit under subsection (b) of Section 12, from each person holding a 16 17 domestic sewage sludge generator or user permit.

Each person subject to this Section must remit the applicable annual fee to the Agency in accordance with the requirements set forth in this Section and any rules adopted pursuant to this Section.

(b) Within 30 days after the effective date of this Section, and each year thereafter, the Agency shall send a fee notice by mail to each existing permittee subject to a fee under this Section at his or her address of record. The notice shall state the amount of the applicable annual fee and the date by which payment is required.

Except as provided in subsection (c) with respect to initial fees under new permits and certain modifications of existing permits, fees payable under this Section are due by the date specified in the fee notice, which shall be no less than 30 days after the date the fee notice is mailed by the - 2 - LRB094 07485 RSP 37649 b

2 (c) The initial annual fee for discharges under a new 3 individual NPDES permit or for activity under a new individual sludge generator or sludge user permit must be remitted to the 4 5 Agency prior to the issuance of the permit. The Agency shall provide notice of the amount of the fee to the applicant during 6 its review of the application. In the case of a new individual 7 8 NPDES or sludge permit issued during the months of January 9 through June, the Agency may prorate the initial annual fee 10 payable under this Section.

11 The initial annual fee for discharges or other activity 12 under a general NPDES permit must be remitted to the Agency as 13 part of the application for coverage under that general permit.

14 If a requested modification to an existing NPDES permit 15 causes a change in the applicable fee categories under 16 subsection (e) that results in an increase in the required fee, 17 the permittee must pay to the Agency the amount of the 18 increase, prorated for the number of months remaining before 19 the next July 1, before the modification is granted.

(d) Failure to submit the fee required under this Section by the due date constitutes a violation of this Section. Late payments shall incur an interest penalty, calculated at the rate in effect from time to time for tax delinquencies under subsection (a) of Section 1003 of the Illinois Income Tax Act, from the date the fee is due until the date the fee payment is received by the Agency.

(e) The annual fees applicable to discharges under NPDESpermits are as follows:

(1) For NPDES permits for publicly owned treatment
works, other facilities for which the wastewater being
treated and discharged is primarily domestic sewage, and
wastewater discharges from the operation of public water
supply treatment facilities, the fee is:

1 per day; 2 (ii) \$5,000 for the 12 months beginning July 1, 2003 and \$2,500 for each subsequent year, for 3 facilities with a Design Average Flow rate of at least 4 5 100,000 gallons per day but less than 500,000 gallons per day; 6 (iii) \$7,500 for facilities with a Design Average 7 Flow rate of at least 500,000 gallons per day but less 8 than 1,000,000 gallons per day; 9 (iv) \$15,000 for facilities with a Design Average 10 11 Flow rate of at least 1,000,000 gallons per day but 12 less than 5,000,000 gallons per day; (v) \$30,000 for facilities with a Design Average 13 Flow rate of at least 5,000,000 gallons per day but 14 less than 10,000,000 gallons per day; and 15 16 (vi) \$50,000 for facilities with a Design Average 17 Flow rate of 10,000,000 gallons per day or more. (2) For NPDES permits for treatment works or sewer 18 collection systems that include combined sewer overflow 19 20 outfalls, the fee is: \$1,000 for systems serving a tributary 21 (i) population of 10,000 or less; 22 (ii) \$5,000 for systems serving a tributary 23 population that is greater than 10,000 but not more 24 25 than 25,000; and (iii) \$20,000 for systems serving a tributary 26 27 population that is greater than 25,000. 28 The fee amounts in this subdivision (e)(2) are in 29 addition to the fees stated in subdivision (e)(1) when the combined sewer overflow outfall is contained within a 30 31 permit subject to subsection (e) (1) fees. 32 (3) For NPDES permits for mines producing coal, the fee is \$5,000. 33 (4) For NPDES permits for mines other than mines 34 producing coal, the fee is \$5,000. 35 36 (5) For NPDES permits for industrial activity where - 4 - LRB094 07485 RSP 37649 b

1 toxic substances are not regulated, other than permits 2 covered under subdivision (e)(3) or (e)(4), the fee is: (i) \$1,000 for a facility with a Design Average 3 Flow rate that is not more than 10,000 gallons per day; 4 5 (ii) \$2,500 for a facility with a Design Average Flow rate that is more than 10,000 gallons per day but 6 not more than 100,000 gallons per day; and 7 (iii) \$10,000 for a facility with a Design Average 8 9 Flow rate that is more than 100,000 gallons per day. 10 (6) For NPDES permits for industrial activity where 11 toxic substances are regulated, other than permits covered 12 under subdivision (e)(3) or (e)(4), the fee is: 13 (i) \$15,000 for a facility with a Design Average Flow rate that is not more than 250,000 gallons per 14 day; and 15 16 (ii) \$20,000 for a facility with a Design Average 17 Flow rate that is more than 250,000 gallons per day. For NPDES permits for industrial activity 18 (7) classified by USEPA as a major discharge, other than 19 20 permits covered under subdivision (e) (3) or (e) (4), the fee 21 is: 22 (i) \$30,000 for a facility where toxic substances 23 are not regulated; and (ii) \$50,000 for a facility where toxic substances 24 25 are regulated. (8) For NPDES permits for municipal separate storm 26 27 sewer systems, the fee is \$1,000. 28 (9) For NPDES permits for construction site or 29 industrial storm water, the fee is \$500. 30 (f) The annual fee for activities under a permit that 31 authorizes applying sludge on land is \$2,500 for a sludge 32 generator permit and \$5,000 for a sludge user permit. More than one of the annual fees specified in 33 (g) 34 subsections (e) and (f) may be applicable to a permit holder. These fees are in addition to any other fees required under 35 this Act. 36

1 (h) The fees imposed under this Section do not apply to the 2 State or any department or agency of the State, nor to any 3 school district, or to any private sewage disposal system as 4 defined in the Private Sewage Disposal Licensing Act (225 ILCS 5 225/).

(h-5) The annual fees applicable to discharges under NPDES 6 permits imposed pursuant to item (i) of subsection (a) of this 7 Section do not apply to (i) a unit of local government, (ii) a 8 9 private sector contractor providing sewage treatment services or infrastructure under contract with the State, any department 10 11 or agency of the State, a unit of local government, or a school district during the course of providing those services, or 12 (iii) a not-for-profit organization exempt under Section 13 501(c) of the Internal Revenue Code of 1986. 14

15 (i) The Agency may adopt rules to administer the fee 16 program established in this Section. The Agency may include 17 provisions pertaining to invoices, notice of late payment, and disputes concerning the amount or timeliness of payment. The 18 19 Agency may set forth procedures and criteria for the acceptance of payments. The absence of such rules does not affect the duty 20 of the Agency to immediately begin the assessment and 21 collection of fees under this Section. 22

(j) All fees and interest penalties collected by the Agency under this Section shall be deposited into the Illinois Clean Water Fund, which is hereby created as a special fund in the State treasury. Gifts, supplemental environmental project funds, and grants may be deposited into the Fund. Investment earnings on moneys held in the Fund shall be credited to the Fund.

30 Subject to appropriation, the moneys in the Fund shall be 31 used by the Agency to carry out the Agency's clean water 32 activities.

33 (k) Except as provided in subsection (l), fees paid to the34 Agency under this Section are not refundable.
