AN ACT concerning health.

## 2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Vital Records Act is amended by changing
Section 25.1 as follows:

6 (410 ILCS 535/25.1) (from Ch. 111 1/2, par. 73-25.1)

7 Sec. 25.1. (a) When the State Registrar of Vital Records receives or prepares a death certificate the Registrar shall 8 make an appropriate notation in the birth certificate record of 9 10 that person that the person is deceased. The Registrar shall also notify the appropriate municipal or county custodian of 11 such birth record that the person is deceased, and such 12 custodian shall likewise make an appropriate notation in its 13 14 records.

15 (b) In response to any inquiry, the Registrar or a custodian shall not provide a copy of a birth certificate or 16 17 information concerning the birth record of any deceased person except as provided in this subsection (b) or as otherwise 18 19 provided in this Act or as approved by the Department. When a 20 the birth certificate of a deceased person is copy of requested, the Registrar or custodian shall require the person 21 22 making the request to complete an information form, which shall 23 be developed and furnished by the Department and shall include, at a minimum, the name, address, telephone number, social 24 25 security number and driver's license number of the person 26 making the request. Before furnishing the copy, the custodian shall prominently stamp on the copy the word "DECEASED" and 27 28 write or stamp on the copy the date of death of the deceased person. The custodian shall retain the information form 29 30 completed by the person making the request, and note on the birth certificate record that such a request was made. The 31 custodian shall make the information form available to the 32

1 Department of State Police or any local law enforcement agency 2 upon request. A city or county custodian shall promptly submit 3 copies of all completed forms to the Registrar. The word "DECEASED" and the date of death shall not appear on a copy of 4 5 a birth certificate furnished to a parent of a child who died within 3 months of birth, provided no other copy of a birth 6 certificate was furnished to the parent prior to the child's 7 death. 8

9 (c) The Registrar shall furnish, no later than 60 days 10 after receipt of a form used to request a birth certificate 11 record of a deceased person, a copy of the form and a copy of 12 the corresponding birth certificate record to the Illinois 13 Department of Public Aid and the Department of Human Services. The Illinois Department of Public Aid and the Department of 14 15 Human Services shall, upon receipt of such information, check 16 their records to ensure that no claim for public assistance 17 under the Illinois Public Aid Code is being made either by a person purporting to be the deceased person or by any person on 18 19 behalf of the deceased person.

20 (d) Notwithstanding the requirements of subsection (b), when the death of a child occurs within 90 days of that child's 21 live birth, the mother listed on the birth certificate of that 22 23 child may request the issuance of a copy of a certificate of live birth from the State Registrar. Such request shall be made 24 in accordance with subsection (b), shall indicate the 25 requestor's relationship to the child, and shall be made not 26 27 later than 9 months from the date of the death of the child. Except as provided herein, the Registrar shall conform to all 28 requirements of this Act in issuing copies of certificates 29 30 under this subsection (d).
