14	Sec. 2.4. Lottery Supports Schools Fund. There is created a

1	Fund to be known as the Lottery Supports Schools Fund, which is
2	a non-appropriated trust fund held outside of the State
3	treasury. The Fund shall consist of moneys paid into it as
4	provided in Section 2.1 of this Act. The Division shall certify
5	each month to the State Board of Education the proportion of
6	lottery sales in each school district in relation to statewide
7	lottery sales. The moneys in the Lottery Supports Schools Fund
8	must be distributed monthly by the State Board of Education to
9	each school district based upon that school district's portion
10	of statewide lottery sales."; and

on page 76, line 10, after "<u>Fund</u>", by inserting "<u>, except those</u> amounts paid into the Lottery Supports Schools Fund as provided in Section 2.1 of this Act"; and

17 <u>Sec. 27.5. No rulemaking authority. Notwithstanding any</u> 18 <u>other provision of this Law or any other rulemaking authority</u> 19 <u>that may exist, on and after the effective date of this</u> 20 <u>amendatory Act of the 95th General Assembly, neither the</u> 21 <u>Governor nor any agency or agency head under the jurisdiction</u> 22 <u>of the Governor has any authority to make or promulgate rules</u> 23 <u>to implement or enforce the provisions of this Law. 1	however, the Governor believes that rules are necessary to
2	implement or enforce the provisions of this Law, the Governor
3	may suggest rules to the General Assembly by filing them with
4	the Clerk of the House and Secretary of the Senate and by
5	requesting that the General Assembly authorize such rulemaking
6	by law, enact those suggested rules into law, or take any other
7	appropriate action in the General Assembly's discretion.
8	Nothing contained in this Law shall be interpreted to grant
9	rulemaking authority under any other Illinois statute where
10	such authority is not otherwise explicitly given. For the
11	purposes of this Law, "rules" is given the meaning contained in
12	Section 1-70 of the Illinois Administrative Procedure Act, and
13	"agency" and "agency head" are given the meanings contained in
14	Sections 1-20 and 1-25 of the Illinois Administrative Procedure
15	Act to the extent that such definitions apply to agencies or
16	agency heads under the jurisdiction of the Governor.".
