AN ACT concerning real property.

## 2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

4 Section 5. Upon payment to the Department of Natural 5 Resources of the sum equal to the appraised fair market value determined in accordance with Section 10, the Director of such 6 7 Department, on behalf of the State of Illinois, is authorized to execute and deliver to WLA Gambit IL, LP, its successors and 8 9 assigns, a quit claim deed to the following described real 10 property, provided the grantee pays the appraisal, land survey, title and closing costs, to wit: 11

All that part of the following described tracts or parcels in Johnson County, Illinois, which lie northerly of the northerly right-of-way line of Interstate Route 24, to wit:

All that part of the Southwest Quarter of Section
 11, Township 13 South, Range 3 East of the Third Principal
 Meridian transferred to the Department of Conservation by
 Document recorded in the Recorder's Office of Johnson
 County, Illinois in Warranty Deed Book 154 at Page 75; and

All that part of the South Half of the Northwest 21 Quarter of Section 11, Township 13 South, Range 3 East of 22 the Third Principal Meridian conveyed to the Department of 23 Conservation by Warranty Deed recorded in the Recorder's 24 Office of Johnson County, Illinois in Warranty Deed Book HB3569 Engrossed - 2 - LRB095 09934 AJO 30146 b

1 117 at Page 341; a more accurate description to be prepared 2 from a Land Survey made by an Illinois Professional Land 3 Surveyor in accordance with the current Illinois minimum 4 standards for a boundary survey, the selection of such 5 Surveyor being subject to approval by the Department of 6 Natural Resources.

7 Section 10. The appraised fair market value of the real 8 property described in Section 5 shall be determined by 3 9 independent State certified general real estate appraisers 10 whose appraisal reports shall be subject to review and 11 certification by the Department of Natural Resources. The legal 12 description of such real property shall be subject to review 13 and approval by the Department of Natural Resources.

14 Section 15. The payment for the appraisal, land survey, 15 title and closing costs, and the amount of the appraised fair 16 market value of the real property to the Department of Natural 17 Resources, as provided in Section 5, shall be made through the 18 Illinois Conservation Foundation, with the funds being 19 earmarked for future land acquisition in IDNR Region 5.

20 Section 20. The Director of Natural Resources shall obtain 21 a certified copy of this Act within 60 days after its effective 22 date and, upon receipt of payment required by Section 5, shall 23 record the certified document in the recorder's office in the HB3569 Engrossed - 3 - LRB095 09934 AJO 30146 b 1 county in which the real property is located.

2 Section 99. Effective date. This Act takes effect upon
