A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much  
6 thereof as may be necessary, respectively, for the objects  
7 and purposes hereinafter named, are appropriated to the Board  
8 of Trustees of the University of Illinois to meet ordinary  
9 and contingent expenses for the fiscal year ending June 30,  
10 2008:

11 Payable from the General Revenue Fund:

12	For Personal Services, including payment	
13	to the university for personal services	
14	costs incurred during the fiscal year	
15	and salaries accrued but unpaid to academic	
16	personnel for personal services rendered	
17	during the academic year 2007-2008 .....	617,042,400
18	For State Contributions to Social	
19	Security, for Medicare .....	9,737,100
20	For Group Insurance .....	24,893,200
21	For Contractual Services .....	44,193,200

1	For Travel .....	249,700
2	For Commodities .....	2,518,600
3	For Equipment .....	511,000
4	For Telecommunications Services .....	5,016,800
5	For Operation of Automotive Equipment .....	967,000
6	For Permanent Improvements .....	750,000
7	For Distributive Purposes as follows:	
8	For Awards and Grants .....	6,057,500
9	For Claims under Workers' Compensation	
10	and Occupational Disease Acts, other	
11	Statutes, and tort claims .....	3,270,000
12	For Hospital and Medical Services

15       Section 10. The sum of \$2,218,500, or so much thereof as  
16 may be necessary, is appropriated from the Fire Prevention  
17 Fund to the Board of Trustees of the University of Illinois  
18 for the purpose of maintaining the Illinois Fire Service  
19 Institute, paying the Institute's expenses, and providing the  
20 facilities and structures incident thereto, including payment  
21 to the University for personal services and related costs  
22 incurred.

23       Section 15. The sum of \$250,000, or so much thereof as

1 may be necessary, is appropriated from the State College and  
2 University Trust Fund to the Board of Trustees of the  
3 University of Illinois for scholarship grant awards, in  
4 accordance with Public Act 91-0083.

5 Section 20. The sum of \$1,000,000, or so much thereof as  
6 may be necessary, is appropriated from the General Revenue  
7 Fund to the University of Illinois for the Complete Help and  
8 Assistance Necessary for a College Education (C.H.A.N.C.E)  
9 program at the Office of School Relations at the Chicago  
10 Campus.

11 Section 99. Effective date. This Act takes effect July 1,  
12 2007.
