# Be it enacted by the People of the State of Illinois, represented in the General Assembly:

#### ARTICLE 1

5	Section 5. The following named amounts, or so much
6	thereof as may be necessary, respectively, for the objects
7	and purposes hereinafter named, are appropriated to the Board
8	of Trustees of the University of Illinois to meet ordinary
9	and contingent expenses for the fiscal year ending June 30,

The sum of \$2,218,500, or so much thereof as may be necessary, is appropriated from the Fire Prevention 16 Fund to the Board of Trustees of the University of Illinois 17 18 for the purpose of maintaining the Illinois Fire Service Institute, paying the Institute's expenses, and providing the 19 20 facilities and structures incident thereto, including payment to the University for personal services and related costs 21 incurred. 22

Section 15. The sum of \$250,000, or so much thereof as

5 Section 20. The sum of \$1,000,000, or so much thereof as 6 may be necessary, is appropriated from the General Revenue 7 Fund to the University of Illinois for the Complete Help and 8 Assistance Necessary for a College Education (C.H.A.N.C.E) 9 program at the Office of School Relations at the Chicago 10 Campus.

Section 99. Effective date. This Act takes effect July 1,
2007.
