A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following amounts, or so much thereof as  
6 may be necessary, respectively, are appropriated for the  
7 objects and purposes named, to meet the ordinary and  
8 contingent expenses of the Illinois Violence Prevention  
9 Authority:

10 Payable from the Violence Prevention Fund:

11	For Personal Services .....	512,400
12	For State Contributions to State	
13	Employees' Retirement System .....	57,300
14	For State Contribution to	
15	Social Security .....	39,200
16	For Group Insurance .....	118,400
17	For Contractual Services .....	43,000

7 Section 10. The sum of \$1,200,000, or so much thereof as  
8 may be necessary, is appropriated from the Violence  
9 Prevention Fund to the Illinois Violence Prevention Authority  
10 for the purpose of awarding grants under the provisions of  
11 the Violence Prevention Act of 1995.

12 Section 15. The sum of \$2,127,500, or so much thereof as  
13 may be necessary, is appropriated from the General Revenue  
14 Fund to the Illinois Violence Prevention Authority for the  
15 purpose of awarding grants under the provisions of the  
16 Violence Prevention Act of 1995.

17 Section 20. The amount of \$849,600, or so much of that  
18 amount as may be necessary, is appropriated from the General  
19 Revenue Fund to the Illinois Violence Prevention Authority  
20 for the Illinois Family Violence Coordinating Council  
21 Program.

1           Section 99. Effective date. This Act takes effect July 1,  
2    2007.
