20 ILCS 3005/9.3 new

Amends the Governor's Office of Management and Budget Act. Requires GOMB to establish a single updated searchable database website accessible by the public at no cost that includes information concerning each entity that receives Illinois funding. Requires GOMB to report to the General Assembly concerning the website. Effective immediately.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Governor's Office of Management and Budget
Act is amended by adding Section 9.3 as follows:

(20 ILCS 3005/9.3 new) 6 7 Sec. 9.3. Illinois Funding Accountability and Transparency 8 Law. 9 (a) In General: (1) Website. Beginning July 1, 2009 and subject to 10 paragraphs (2) and (3), the Governor's Office of Management 11 12 and Budget (GOMB) shall ensure the existence and operation of a single updated searchable database website accessible 13 14 by the public at no cost that includes for each entity receiving Illinois funding: 15

(A) the name of the entity;
