Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Section 115. The sum of \$5,000,000, or so much thereof may be necessary, is appropriated from the Federal Student Incentive Trust Fund to the Illinois Student Assistance Commission for payment of grants for the Federal College

- 1 Access Challenge Grant Program, with up to six percent of the
- 2 funding appropriated to meet allowable administrative costs,
- 3 as part of the College Cost Reduction and Access Act (CCRAA),
- 4 as provided by law.
- 5 Section 120. The sum of \$2,128,100, or so much thereof
- 6 as may be necessary, is appropriated from the Student Loan
- 7 Operating Fund to the Illinois Student Assistance Commission
- 8 for costs and expenses related to or in support of a higher
- 9 education shared services center.
- 10 Section 999. Effective Date. This Act takes effect July
- 11 1, 2008.
