HOUSE RESOLUTION

2 WHEREAS, The members of the Illinois House of
3 Representatives are pleased to congratulate Homewood Police
4 Chief Larry Burnson on the occasion of being selected by the
5 Illinois State Crime Commission as the 2008 Police Chief of the
6 Year; and

7 WHEREAS, Larry Burnson earned his associate's degree in Law
8 Enforcement from South Suburban College, his bachelor's degree
9 in Criminal Justice from Lewis University, and his master's
10 degree in Public Administration from DePaul University; and

11 WHEREAS, Larry Burnson began his law enforcement career
12 with the Matteson Police Department on October 1, 1974; he rose
13 through the ranks of the department to become Matteson's Police
14 Chief on August 1, 1991, remaining in that position until his
15 retirement on December 7, 2001; and

16 WHEREAS, On December 10, 2001, Larry Burnson began his
17 second law enforcement career as the Chief of Police for the
18 Homewood Police Department, a position he currently serves in
19 with dignity and integrity; and

20 WHEREAS, Larry Burnson is a past president of the South
21 Suburban Association of Chiefs of Police; he is the founding

1 father and past chairperson of the Family & Youth Initiative of
2 Rich Township; he has served as vice-president of the Unity
3 Coalition of the South Suburbs and as an adjunct faculty member
4 at Prairie State College; he is a life member of the
5 International Association of Chiefs of Police and served as
6 President of the Illinois Association of Chiefs of Police in
7 2007; he has also served as an active member of the Illinois
8 Association of Chiefs of Police since 1981, having served on
9 the legislative, auditing, conference, gang awareness, and
10 domestic violence committees during his many years there; and

11 WHEREAS, Larry Burnson currently serves as a member of the
12 Dare International Law Enforcement Advisory Board, a member of
13 the International Association of Chiefs of Police Civil Rights
14 Committee, and as treasurer of the South Suburban Major Crimes
15 Task Force; and

16 WHEREAS, Larry Burnson was selected by Illinois State Crime
17 Commission Executive Director Jerry Elsner along with the Board
18 Members of the Illinois State Crime Commission for this honor
19 due to his impressive achievements and service to many
20 professional and civic organizations; he will be officially
21 awarded this honor in June of 2008 at the annual "Salute to
22 those Who Make a Difference" award ceremony; and

23 WHEREAS, Larry Burnson's dedication to his profession and

1 his willingness to serve his community make him a model for the
2 people of the State of Illinois; therefore, be it
