AMENDMENT TO HOUSE BILL 244

AMENDMENT NO. \_\_\_\_\_\_. Amend House Bill 244 by replacing everything after the enacting clause with the following:

"Section 5. The State Employees Group Insurance Act of 1971 is amended by changing Section 6.11 as follows:
