1 AMENDMENT TO HOUSE BILL 2257 2 AMENDMENT NO. . Amend House Bill 2257 as follows: 3 on page 2, line 21 by replacing "Department" with "Sheriff's office of the county in which the applicant resides"; and 4 5 on page 3, line 15, immediately after the period, by adding the 6 following: 7 "The applicant must submit his or her application to the sheriff's office of the county in which he or she resides and 8 must be fingerprinted at that time. A fee of not more than \$25 9 10 may be collected from the sheriff's department for the 11 fingerprinting. The sheriff's office will then submit the 12 application, fingerprints, and licensing fee to the Department 13 within 48 hours of receipt. If the applicant is subject to an investigation or pending criminal charges that would cause the 14 15 applicant, if convicted, to be ineligible for licensing, then

the county sheriff may include this information with the
