1 AMENDMENT TO HOUSE BILL 2625

2 AMENDMENT NO. _____. Amend House Bill 2625 by replacing
3 everything after the enacting clause with the following:

4 "Section 5. The State Finance Act is amended by adding
5 Section 5.719 as follows:

6 (30 ILCS 105/5.719 new)

7 Sec. 5.719. The International Brotherhood of Teamsters
8 Fund.

9 Section 10. The Illinois Vehicle Code is amended by adding
10 Section 3-684 as follows:

11 (625 ILCS 5/3-684 new)

12 Sec. 3-684. International Brotherhood of Teamsters license
13 plate.

14 (a) The Secretary, upon receipt of all applicable fees and

1 applications made in the form prescribed by the Secretary, may
2 issue special registration plates designated as International
3 Brotherhood of Teamsters license plates. The special plates
4 issued under this Section shall be affixed only to passenger
5 vehicles of the first division, motor vehicles of the second
6 division weighing not more than 8,000 pounds, recreational
7 vehicles as defined by Section 1-169 of this Code, and boat
8 trailers with a gross trailer weight rating of 10,000 or less
9 pounds. Plates issued under this Section shall expire according
10 to the multi-year procedure established by Section 3-414.1 of
11 this Code.

12 (b) The design and color of the plates is wholly within the
13 discretion of the Secretary of State. Appropriate
14 documentation, as determined by the Secretary, shall accompany
15 the application. The Secretary, in his or her discretion, may
16 allow the plates to be issued as vanity or personalized plates
17 under Section 3-405.1 of this Code. The Secretary shall
18 prescribe stickers or decals as provided under Section 3-412 of
19 this Code.

20 (c) An applicant for the special plate shall be charged a
21 \$40 fee for original issuance in addition to the appropriate
22 registration fee. Of this fee, \$25 shall be deposited into the
23 International Brotherhood of Teamsters Fund and \$15 shall be
24 deposited into the Secretary of State Special License Plate
25 Fund, to be used by the Secretary to help defray the
26 administrative processing costs.

1 For each registration renewal period, a \$27 fee, in
2 addition to the appropriate registration fee, shall be charged.
3 Of this fee, \$25 shall be deposited into the International
4 Brotherhood of Teamsters Fund and \$2 shall be deposited into
5 the Secretary of State Special License Plate Fund.

6 (d) The International Brotherhood of Teamsters Fund is
7 created as a special fund in the State treasury. All money in
8 the International Brotherhood of Teamsters Fund shall be paid,
9 subject to appropriation by the General Assembly and approval
10 by the Secretary of State, as grants to the Teamsters Joint
11 Council 25 Charitable Trust, an independent organization
12 established and registered as a tax exempt entity under Section
13 501(c)(3) of the Internal Revenue Code, for religious,
14 charitable, scientific, literary, educational, and
15 labor-related purposes, including networking with existing
16 human service systems, providing assistance and information to
17 human service delivery systems on issues affecting labor and
18 employment, and providing members of various unions which make
19 up Teamsters Joint Council 25 with appropriate assistance when
20 needed."
