Be it enacted by the People of the State of Illinois, represented in the General Assembly:

ARTICLE 41

6 Section 10. The sum of \$1,200,000, or so much thereof as 7 may be necessary, is appropriated from the Violence 8 Prevention Fund to the Illinois Violence Prevention Authority 9 for the purpose of awarding grants under the provisions of 10 the Violence Prevention Act of 1995.

Section 15. The sum of \$2,063,700, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Illinois Violence Prevention Authority for the purpose of awarding grants under the provisions of the Violence Prevention Act of 1995.

16 Section 20. The amount of \$824,100, or so much of that 17 amount as may be necessary, is appropriated from the General 18 Revenue Fund to the Illinois Violence Prevention Authority 19 for the Illinois Family Violence Coordinating Council 20 Program.

21 Section 25. The amount of \$485,000, or so much thereof

Section 99. Effective date. This Act takes effect July 1,
2009.
