A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much  
6 thereof as may be necessary, respectively, for the objects  
7 and purposes hereinafter named, are appropriated to the Board  
8 of the Trustees of Chicago State University to meet ordinary  
9 and contingent expenses for the fiscal year ending June 30,  
10 2010:

11 Payable from the General Revenue Fund:

12	For Personal Services, including payment	
13	to the university for personal services	
14	costs incurred during the fiscal year	
15	and salaries accrued but unpaid to academic	
16	personnel for personal services rendered	
17	during the academic year 2009-2010 .....	34,338,700
18	For State Contributions to Social	
19	Security, for Medicare .....	378,100
20	For Group Insurance .....	1,003,300
21	For Contractual Services .....	1,952,400

1	For Travel .....	10,800
2	For Commodities .....	10,800
3	For Equipment .....	164,600
4	For Telecommunications Services .....	298,300
5	For Operation of Automotive Equipment .....	1,000
6	For Awards and Grants .....	<u>102,300</u>
7	Total	\$38,260,300

8 Section 10. The sum of \$400,000, or so much thereof as  
 9 may be necessary, is appropriated from the General Revenue  
 10 Fund to Board of Trustees of Chicago State University for  
 11 collaboration projects to improve retention and graduation  
 12 rates.

13 Section 15. The sum of 614,000, or so much thereof as  
 14 may be necessary, is appropriated from the General  
 15 Professions Dedicated Fund to the Board of Trustees of  
 16 Chicago State University for all costs associated with the  
 17 development, support or administration of pharmacy practice  
 18 education or training programs.

19 Section 20. In addition to any other amounts  
 20 appropriated for such purposes, the following named amount,  
 21 or so much thereof as may be necessary, is appropriated from  
 22 the General Revenue Fund to the Board of Trustees of Chicago

1 State University for the fiscal year beginning July 1, 2009,  
 2 pursuant to Title XIV of the American Recovery and  
 3 Reinvestment Act of 2009:

4 For Personal Services .....\$3,451,700

5 Section 25. In addition to any other amounts  
 6 appropriated for such purposes, the following named amounts,  
 7 or so much thereof as may be necessary, are appropriated from  
 8 the General Revenue Fund to the Board of Trustees of Chicago  
 9 State University for the fiscal year beginning July 1, 2009,  
 10 pursuant to Title XIV (Other Government Services) of the  
 11 American Recovery and Reinvestment Act of 2009:

12 For Personal Services .....\$419,600

13 Section 99. Effective date. This Act takes effect July 1,  
 14 2009.
