A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much  
6 thereof as may be necessary, respectively, for the objects  
7 and purposes hereinafter named, are appropriated to the Board  
8 of the Trustees of Eastern Illinois University to meet  
9 ordinary and contingent expenses for the fiscal year ending  
10 June 30, 2010:

11 Payable from the General Revenue Fund:

12	For Personal Services, including payment	
13	to the university for personal services	
14	costs incurred during the fiscal year	
15	and salaries accrued but unpaid to academic	
16	personnel for personal services rendered	
17	during the academic year 2009-2010 .....	45,509,500
18	For Contractual Services .....	1,000,000
19	For Commodities .....	300,000
20	For Equipment .....	500,000
21	For Telecommunications Services .....	<u>300,000</u>

1 Total \$47,609,500

2 Section 10. The sum of \$4,250, or so much thereof as may  
3 be necessary, is appropriated from the State College and  
4 University Trust Fund to the Board of Trustees of Eastern  
5 Illinois University for scholarship grant awards, in  
6 accordance with Public Act 91-0083.

7 Section 15. In addition to any other amounts appropriated  
8 for such purposes, the following named amounts or so much  
9 thereof as may be necessary, is appropriated from the General  
10 Revenue Fund to the Board of Trustees of Eastern Illinois  
11 University for the fiscal year beginning July 1, 2009,  
12 pursuant to Title XIV of the American Recovery and  
13 Reinvestment Act of 2009:

14 For Personal Services .....\$2,957,000

15 Section 20. In addition to any other amounts appropriated for  
16 such purposes, the following named amounts, or so much  
17 thereof as may be necessary, are appropriated from the  
18 General Revenue Fund to the Board of Trustees of Eastern  
19 Illinois University for the fiscal year beginning July 1,  
20 2009, pursuant to Title XIV (Other Government Services) of  
21 the American Recovery and Reinvestment Act of 2009:

22 For Personal Services .....\$836,300

1           Section 99. Effective date. This Act takes effect July 1,  
2    2009.
