

## 96TH GENERAL ASSEMBLY State of Illinois 2009 and 2010 HB5312

Introduced 2/5/2010, by Rep. Angelo Saviano

## SYNOPSIS AS INTRODUCED:

40 ILCS 5/6-128.4 30 ILCS 805/8.34 new from Ch. 108 1/2, par. 6-128.4

Amends the Chicago Firefighter Article of the Illinois Pension Code. Increases the minimum widow's annuity to \$1,050 beginning January 1, 2011, \$1,100 beginning January 1, 2012, \$1,150 beginning January 1, 2013, and \$1,200 beginning January 1, 2014. Amends the State Mandates Act to require implementation without reimbursement. Effective immediately.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Illinois Pension Code is amended by changing

  Section 6-128.4 as follows:
- 6 (40 ILCS 5/6-128.4) (from Ch. 108 1/2, par. 6-128.4)
- 7 Sec. 6-128.4. Minimum widow's annuities.
- 8 (a) Notwithstanding any other provision of this Article,
  9 beginning January 1, 1996, the minimum amount of widow's
  10 annuity payable to any person who is entitled to receive a
  11 widow's annuity under this Article is \$700 per month, without
  12 regard to whether the deceased fireman is in service on or
- after the effective date of this amendatory Act of 1995.

  (b) Notwithstanding Section 6-128.3, beginning January 1,
- 15 1994, the minimum widow's annuity under this Article shall be
- 16 \$700 per month for (1) all persons receiving widow's annuities
- on that date who are survivors of employees who retired at age
- 18 50 or over with at least 20 years of service, and (2) persons
- 19 who become eligible for widow's annuities and are survivors of
- 20 employees who retired at age 50 or over with at least 20 years
- 21 of service.
- 22 (c) Notwithstanding Section 6-128.3, beginning January 1,
- 23 1999, the minimum widow's annuity under this Article shall be

- \$800 per month for (1) all persons receiving widow's annuities on that date who are survivors of employees who retired at age 50 or over with at least 20 years of service, and (2) persons who become eligible for widow's annuities and are survivors of employees who retired at age 50 or over with at least 20 years of service.
  - (d) Notwithstanding Section 6-128.3, beginning January 1, 2004, the minimum widow's annuity under this Article shall be \$900 per month for all persons receiving widow's annuities on or after that date, without regard to whether the deceased fireman is in service on or after the effective date of this amendatory Act of the 93rd General Assembly.
  - (e) Notwithstanding Section 6-128.3, beginning January 1, 2005, the minimum widow's annuity under this Article shall be \$1,000 per month for all persons receiving widow's annuities on or after that date, without regard to whether the deceased fireman is in service on or after the effective date of this amendatory Act of the 93rd General Assembly.
  - (f) Notwithstanding Section 6-128.3, beginning January 1, 2011, the minimum widow's annuity under this Article shall be \$1,050 per month for all persons receiving widow's annuities on or after that date, without regard to whether the deceased fireman is in service on or after the effective date of this amendatory Act of the 96th General Assembly.
  - (g) Notwithstanding Section 6-128.3, beginning January 1, 2012, the minimum widow's annuity under this Article shall be

- 1 \$1,100 per month for all persons receiving widow's annuities on
- 2 or after that date, without regard to whether the deceased
- 3 <u>fireman is in service on or after the effective date of this</u>
- 4 <u>amendatory Act of the 96th General Assembly.</u>
- 5 (h) Notwithstanding Section 6-128.3, beginning January 1,
- 6 2013, the minimum widow's annuity under this Article shall be
- 7 \$1,150 per month for all persons receiving widow's annuities on
- 8 or after that date, without regard to whether the deceased
- 9 fireman is in service on or after the effective date of this
- amendatory Act of the 96th General Assembly.
- 11 (i) Notwithstanding Section 6-128.3, beginning January 1,
- 12 2014, the minimum widow's annuity under this Article shall be
- \$1,200 per month for all persons receiving widow's annuities on
- or after that date, without regard to whether the deceased
- 15 fireman is in service on or after the effective date of this
- amendatory Act of the 96th General Assembly.

- 18 Section 90. The State Mandates Act is amended by adding
- 19 Section 8.34 as follows:
- 20 (30 ILCS 805/8.34 new)
- Sec. 8.34. Exempt mandate. Notwithstanding Sections 6 and 8
- of this Act, no reimbursement by the State is required for the
- implementation of any mandate created by this amendatory Act of
- the 96th General Assembly.
