1 (b) Upon receiving a request from a federally licensed 2 firearm dealer, gun show promoter, or gun show vendor, the 3 Department of State Police shall immediately approve, or within 4 the time period established by Section 24-3 of the Criminal 5 Code of 1961 regarding the delivery of firearms, stun guns, and 6 tasers notify the inquiring dealer, gun show promoter, or gun show vendor of any objection that would disqualify the 7 8 transferee from acquiring or possessing a firearm, stun gun, or taser. In conducting the inquiry, the Department of State 9 10 Police shall initiate and complete an automated search of its 11 criminal history record information files and those of the Investigation, including the National 12 Federal Bureau of Instant Criminal Background Check System, and of the files of 13 the Department of Human Services relating to mental health and 14 15 developmental disabilities to obtain any felony conviction or 16 patient hospitalization information which would disqualify a person from obtaining or require revocation of a currently 17 valid Firearm Owner's Identification Card. 18

(c) If receipt of a firearm would not violate Section 24-3
of the Criminal Code of 1961, federal law, or this Act the
Department of State Police shall:

(1) assign a unique identification number to the transfer; and

24 (2) provide the licensee, gun show promoter, or gun25 show vendor with the number.

26 (d) Approvals issued by the Department of State Police for

1 the purchase of a firearm are valid for 30 days from the date 2 of issue.

3 (e) (1) The Department of State Police must act as the
4 Illinois Point of Contact for the National Instant Criminal
5 Background Check System.

6 (2) The Department of State Police and the Department of Human Services shall, in accordance with State and federal law 7 8 regarding confidentiality, enter into a memorandum of 9 understanding with the Federal Bureau of Investigation for the 10 of implementing the National Instant Criminal purpose 11 Background Check System in the State. The Department of State Police shall report the name, date of birth, and physical 12 13 description of any person prohibited from possessing a firearm pursuant to the Firearm Owners Identification Card Act or 18 14 15 U.S.C. 922(q) and (n) to the National Instant Criminal 16 Background Check System Index, Denied Persons Files.

17 (f) The Department of State Police shall promulgate rules18 not inconsistent with this Section to implement this system.

19 <u>(q) The Department of State Police shall develop an</u> 20 <u>Internet based system for individuals to request the Department</u> 21 <u>of State Police to conduct an instant criminal background check</u> 22 <u>prior to the sale or transfer of a handgun. The Department of</u> 23 <u>State Police shall have the system completed and available for</u> 24 <u>use by July 1, 2012. The Department shall promulgate rules not</u> 25 <u>inconsistent with this Section to implement this system.</u>
