1 AMENDMENT TO HOUSE BILL 5578

2 AMENDMENT NO. \_\_\_\_\_. Amend House Bill 5578 by replacing  
3 everything after the enacting clause with the following:

4 "Section 5. The University of Illinois Act is amended by  
5 changing Section 30 as follows:

6 (110 ILCS 305/30)

7 Sec. 30. Provision of student and social security  
8 information prohibited.

9 (a) The University, including its agents, employees,  
10 student or alumni organizations, or any affiliates, may not  
11 provide a student's name, address, telephone number, social  
12 security number, e-mail address, or other personal identifying  
13 information to a business organization or financial  
14 institution that issues credit or debit cards, unless the  
15 student is 21 years of age or older. This prohibition does not  
16 apply to service providers of the University that (i) assist

1 the University in the electronic disbursement of refunds,  
2 including, but not limited to, financial aid refunds, and (ii)  
3 do not provide loan or credit services.

4 (b) The University may not print an individual's social  
5 security number on any card or other document required for the  
6 individual to access products or services provided by the  
7 University.

9 Section 10. The Southern Illinois University Management  
10 Act is amended by changing Section 16 as follows:

12 Sec. 16. Provision of student and social security  
13 information prohibited.

15 student or alumni organizations, or any affiliates, may not  
16 provide a student's name, address, telephone number, social  
17 security number, e-mail address, or other personal identifying  
18 information to a business organization or financial  
19 institution that issues credit or debit cards, unless the  
20 student is 21 years of age or older. This prohibition does not  
21 apply to service providers of the University that (i) assist  
22 the University in the electronic disbursement of refunds,  
23 including, but not limited to, financial aid refunds, and (ii)  
24 do not provide loan or credit services.

1 (b) The University may not print an individual's social  
2 security number on any card or other document required for the  
3 individual to access products or services provided by the  
4 University.

13 provide a student's name, address, telephone number, social  
14 security number, e-mail address, or other personal identifying  
15 information to a business organization or financial  
16 institution that issues credit or debit cards, unless the  
17 student is 21 years of age or older. This prohibition does not  
18 apply to service providers of the University that (i) assist  
19 the University in the electronic disbursement of refunds,  
20 including, but not limited to, financial aid refunds, and (ii)  
21 do not provide loan or credit services.

11 security number, e-mail address, or other personal identifying  
12 information to a business organization or financial  
13 institution that issues credit or debit cards, unless the  
14 student is 21 years of age or older. This prohibition does not  
15 apply to service providers of the University that (i) assist  
16 the University in the electronic disbursement of refunds,  
17 including, but not limited to, financial aid refunds, and (ii)  
18 do not provide loan or credit services.

10 information to a business organization or financial  
11 institution that issues credit or debit cards, unless the  
12 student is 21 years of age or older. This prohibition does not  
13 apply to service providers of the University that (i) assist  
14 the University in the electronic disbursement of refunds,  
15 including, but not limited to, financial aid refunds, and (ii)

7 security number, e-mail address, or other personal identifying  
8 information to a business organization or financial  
9 institution that issues credit or debit cards, unless the  
10 student is 21 years of age or older. This prohibition does not  
11 apply to service providers of the University that (i) assist  
12 the University in the electronic disbursement of refunds,  
13 including, but not limited to, financial aid refunds, and (ii)  
14 do not provide loan or credit services.

7 student is 21 years of age or older. This prohibition does not  
8 apply to service providers of the University that (i) assist  
9 the University in the electronic disbursement of refunds,  
10 including, but not limited to, financial aid refunds, and (ii)  
11 do not provide loan or credit services.

6 the University in the electronic disbursement of refunds,  
7 including, but not limited to, financial aid refunds, and (ii)

23 information to a business organization or financial  
24 institution that issues credit or debit cards, unless the



1 student is 21 years of age or older. This prohibition does not  
2 apply to service providers of the University that (i) assist  
3 the University in the electronic disbursement of refunds,  
4 including, but not limited to, financial aid refunds, and (ii)  
5 do not provide loan or credit services.

16 (a) A community college, including its agents, employees,  
17 student or alumni organizations, or any affiliates, may not  
18 provide a student's name, address, telephone number, social  
19 security number, e-mail address, or other personal identifying  
20 information to a business organization or financial  
21 institution that issues credit or debit cards, unless the  
22 student is 21 years of age or older. This prohibition does not  
23 apply to service providers of the community college that (i)  
24 assist the community college in the electronic disbursement of

1 refunds, including, but not limited to, financial aid refunds,  
2 and (ii) do not provide loan or credit services.

3 (b) A community college may not print an individual's  
4 social security number on any card or other document required  
5 for the individual to access products or services provided by  
6 the community college.

8 Section 99. Effective date. This Act takes effect upon  
9 becoming law."
