Be it enacted by the People of the State of Illinois, represented in the General Assembly:

7	Firefighter Ceremony, and other expenses as allowed under
8	Public Act 91-0832.

- 2 Section 40. The sum of \$550,000, or so much thereof as
- 3 may be necessary, is appropriated from the Underground
- 4 Storage Tank Fund to the Office of the State Fire Marshal for
- 5 a grant to the City of Chicago for Administrative Costs
- 6 incurred as a result of the State's Underground Storage
- 7 Program.
- 8 Section 45. The sum of \$125,000, or so much thereof as
- 9 may be necessary, is appropriated from the Fire Prevention
- 10 Fund to the Office of the State Fire Marshal for grants
- 11 available for costs and services related to ILEAS/MABAS
- 12 administration.
- 13 Section 50. The sum of \$25,000, or so much thereof as
- 14 may be necessary, is appropriated from the Fire Prevention
- 15 Fund to the Office of the State Fire Marshal for grants
- 16 available for the NITE project.
- 17 Section 55. The sum of \$5,000, or so much thereof as may
- 18 be necessary, is appropriated from the Cigarette Fire Safety
- 19 Standard Fund to the Office of the State Fire Marshal for the
- 20 purpose of fire safety and prevention programs.

- Section 60. The sum of \$76,900, or so much thereof as
- 2 may be necessary, is appropriated from the Fire Service and
- 3 Small Equipment Fund to the Office of the State Fire Marshal
- 4 for the purpose of providing small equipment grants.
- 5 Section 99. Effective date. This Act takes effect July 1,
- 6 2010.
