A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

1 Controlled Substances Act, and the Environmental Safety Act.

2 Section 15. The sum of \$2,000,000, or so much thereof as  
3 may be necessary, is appropriated from the Federal Asset  
4 Forfeiture Fund to the Department of State Police for payment  
5 of their expenditures in accordance with the Federal  
6 Equitable Sharing Guidelines.

7 Section 20. The following named amounts, or so much

1 Police for Terrorism Task Force Approved Purchases for  
2 Homeland Security.

3 Section 45. The following amounts, or so much thereof as  
4 may be necessary for objects and purposes hereinafter named,  
5 are appropriated from the Drug Traffic Prevention Fund to the  
6 Department of State Police, Division of Operations, pursuant  
7 to the provisions of the "Intergovernmental Drug Laws  
8 Enforcement Act" for Grants to Metropolitan Enforcement  
9 Groups.

10 For Grants to Metropolitan Enforcement Groups:

11 Payable from the Drug Traffic  
12 Prevention Fund .....150,000

13 Section 50. In the event of the receipt of funds from  
14 the Motor Vehicle Theft Prevention Council, through a grant  
15 from the Criminal Justice Information Authority, the amount  
16 of \$600,000, or so much thereof as may be necessary, is  
17 appropriated from the State Police Motor Vehicle Theft  
18 Prevention Trust Fund to the Department of State Police for  
19 payment of expenses.

20 Section 55. The sum of \$8,250,000 or so much thereof as  
21 may be necessary, is appropriated from the State Police  
22 Whistleblower Reward and Protection Fund to the Department of



1 State Police for payment of their expenditures for state law  
 2 enforcement purposes in accordance with the State  
 3 Whistleblower Protection Act.

4 Section 60. The following amounts, or so much thereof as  
 5 may be necessary, respectively, are appropriated from the  
 6 General Revenue Fund to the Department of State Police for  
 7 the expenses of Fraud Investigations:

19 Section 65. The sum of \$250,000, or so much thereof as  
 20 may be necessary, is appropriated from the Medicaid Fraud and  
 21 Abuse Prevention Fund to the Department of State Police,  
 22 Division of Operations - Financial Fraud and Forgery Unit for

1 the detection, investigation or prosecution of recipient or  
2 vendor fraud.

3 Section 70. The following named amounts, or so much  
4 thereof as may be necessary, respectively, are appropriated  
5 to the Department of State Police for the following purposes:

22 Section 95. The sum of \$500,000, or so much thereof as  
23 may be necessary, is appropriated to the Department of State

1 Police, Division of Administration, from the Money Laundering  
2 Asset Recovery Fund for the ordinary and contingent expenses  
3 incurred by the Department of State Police.

4 Section 99. Effective date. This Act takes effect July 1,  
5 2010.
