2	AMENDMENT NO Amend Senate Bill 642 as follows:
3	in Section 5, Sec. 7, subsec. (c), immediately above the
4	paragraph beginning "For the purposes", by inserting the
5	following:
6	"If the Board of Trustees exercises its power to borrow
7	money under this subsection (c), then the Board is prohibited
8	from using the proceeds of the debt issuance to pay any portion
9	of the salary of those University employees whose salaries
10	place them in the top 10% of wage earners at the University and
11	who are not members of a collective bargaining unit."; and
12	in Section 10, Sec. 8, subdivision 13, immediately above the
13	paragraph beginning "For the purposes", by inserting the
14	following:
15	"If the Board exercises its power to borrow money under
16	this item 13 then the Board is prohibited from using the

1	proceeds of the debt issuance to pay any portion of the
2	salary of those University employees whose salaries place
3	them in the top 10% of wage earners at the University and
4	who are not members of a collective bargaining unit."; and

- 5 in Section 15, Sec. 5-45, subdivision (13), immediately above
- 6 the paragraph beginning "For the purposes", by inserting the
- 7 following:
- 8 "If the Board exercises its power to borrow money under
- 9 this item (13), then the Board is prohibited from using the
- 10 proceeds of the debt issuance to pay any portion of the salary
- of those University employees whose salaries place them in the
- 12 top 10% of wage earners at the University and who are not
- members of a collective bargaining unit."; and
- 14 in Section 20, Sec. 10-45, subsec. (a), subdivision (12),
- immediately above the paragraph beginning "For the purposes",
- 16 by inserting the following:
- "If the Board exercises its power to borrow money under
- this item (12), then the Board is prohibited from using the
- 19 proceeds of the debt issuance to pay any portion of the
- 20 salary of those University employees whose salaries place
- them in the top 10% of wage earners at the University and
- who are not members of a collective bargaining unit."; and
- in Section 25, Sec. 15-45, subdivision (13), immediately above

- 1 the paragraph beginning "For the purposes", by inserting the
- 2 following:
- 3 "If the Board exercises its power to borrow money under
- 4 this item (13), then the Board is prohibited from using the
- 5 proceeds of the debt issuance to pay any portion of the salary
- of those University employees whose salaries place them in the
- 7 top 10% of wage earners at the University and who are not
- 8 members of a collective bargaining unit."; and
- 9 in Section 30, Sec. 20-45, subdivision (14), immediately above
- 10 the paragraph beginning "For the purposes", by inserting the

- in Section 33, Sec. 25-45, subdivision (13), immediately above
- 19 the paragraph beginning "For the purposes", by inserting the
- 20 following:
- "If the Board exercises its power to borrow money under

- 23 proceeds of the debt issuance to pay any portion of the salary
- of those University employees whose salaries place them in the

- 1 top 10% of wage earners at the University and who are not
- 2 members of a collective bargaining unit."; and
- 3 in Section 35, Sec. 30-45, subdivision (14), immediately above
- 4 the paragraph beginning "For the purposes", by inserting the
- 5 following:
- "If the Board exercises its power to borrow money under 6
- this item (14), then the Board is prohibited from using the 7
- 8 proceeds of the debt issuance to pay any portion of the salary
- 9 of those University employees whose salaries place them in the
- 10 top 10% of wage earners at the University and who are not
- members of a collective bargaining unit."; and 11
- 12 in Section 40, Sec. 35-45, subdivision (13), immediately above
- 13 the paragraph beginning "For the purposes", by inserting the
- 14 following:
- "If the Board exercises its power to borrow money under 15
- this item (13), then the Board is prohibited from using the 16
- 17 proceeds of the debt issuance to pay any portion of the salary
- 18 of those University employees whose salaries place them in the
- top 10% of wage earners at the University and who are not 19
- 20 members of a collective bargaining unit.".
