AN ACT making appropriations and reappropriations.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 Section 5. The following named amounts, or so much thereof as may be necessary, respectively, for the objects 5 and purposes hereinafter named, are appropriated to the Board 6 the Trustees of the University of Illinois to meet 7 of 8 ordinary and contingent expenses for the fiscal year ending 9 June 30, 2010: Payable from the General Revenue Fund: 10 11 For Personal Services, including payment to the university for personal services 12 costs incurred during the fiscal year 13 14 and salaries accrued but unpaid to academic personnel for personal services rendered 15 during the 2009-2010 academic year\$641,354,200 16 For State Contributions to Social 17 18 19 20 21 22 23

Section 10. The sum of \$15,826,500, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Board of Trustees of the University of Illinois for operating costs and expenses related to or in support of the Institute of Natural Resource Sustainability, in accordance with Public Act 95-728.

14 Section 15. The sum of \$2,445,500, or so much thereof as 15 may be necessary, is appropriated from the Fire Prevention 16 Fund to the Board of Trustees of the University of Illinois 17 for the purpose of maintaining the Illinois Fire Service 18 Institute, paying the Institute's expenses, and providing the 19 facilities and structures incident thereto, including payment SB1452 -3- LRB096 08895 NHT 19030 b 1 to the University for personal services and related costs 2 incurred.

3 Section 20. The sum of \$250,000, or so much thereof as 4 may be necessary, is appropriated from the State College and 5 University Trust Fund to the Board of Trustees of the 6 University of Illinois for scholarship grant awards, in 7 accordance with Public Act 91-83.

8 Section 25. The sum of \$1,000,000, or so much thereof as 9 may be necessary, is appropriated from the General Revenue 10 Fund to the University of Illinois for the Complete Help and 11 Assistance Necessary for a College Education (C.H.A.N.C.E) 12 program at the Office of School Relations at the Chicago 13 campus.

Section 30. The sum of \$800,000, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Board of Trustees of the University of Illinois for costs associated with the Hispanic Center for Excellence at the Chicago campus.

20 Section 35. The sum of \$200,000, or so much thereof as 21 may be necessary, is appropriated from the Emergency Public 22 Health Fund to the University of Illinois for costs and

The sum of \$350,000, or so much thereof as may 15 16 be necessary, is appropriated from the General Revenue Fund to the Board of Trustees of the University of Illinois for a 17 18 grant to the College of Dentistry. Section 55. The sum of \$350,000, or so much thereof as 19 20 may be necessary, is appropriated from the General Revenue Fund to the Board of Trustees of the University of Illinois 21 for Dixon Springs Agricultural Center. 22

24 Section 60. The sum of \$1,250,000, or so much thereof as

6 Section 65. The sum of \$1,000,000, or so much thereof as necessary, is appropriated from the General 7 may be Professions Dedicated Fund to the Board of Trustees of the 8 University of Illinois for costs associated with 9 the 10 development, support, or administration of pharmacy practice 11 education or training programs for the College of Medicine at Rockford. 12

Section 70. The sum of \$1,000,000, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Board of Trustees of the University of Illinois for the ordinary and contingent expenses of technology transfer.

18 Section 75. The sum of \$4,386,034, or so much thereof as 19 may be necessary and remains unexpended at the close of 20 business on June 30, 2009, from a reappropriation heretofore 21 made for that purpose in Article 40, Section 5 of Public Act 22 95-734, as amended, is reappropriated from the Capital 23 Development Fund to the Board of Trustees of the University -6- LRB096 08895 NHT 19030 b

of Illinois for all costs associated with the space needs of the Department of Natural Resources, Illinois Natural History Survey Division and State Water Survey Division, on the campus of the University of Illinois in Champaign, including construction, capital facilities, planning, relocation, renovation and rehabilitation, mechanical systems, materials, services, and all other costs required to complete the work.

Section 80. The sum of \$134,917, or so much thereof as 8 may be necessary and remains unexpended on June 30, 2009, 9 10 from a reappropriation heretofore made for such purpose in Public Section of 11 Article 40, 10 Act 95-734, is 12 reappropriated from the Capital Development Fund to the University of Illinois for digitalization infrastructure for 13 WILL-TV (Urbana-Champaign). 14

15 Section 99. Effective date. This Act takes effect July 1,16 2009.
