1 linearly-scalable data warehouse to encompass other healthcare 2 data sources at both the Department of Human Services and the 3 Department of Public Health. The Department of Healthcare and Family Services shall leverage the inherent capabilities of the 4 5 data warehouse to accomplish this expansion with marginal 6 additional technical administration. The purpose of this expansion is to allow for programmatic review and analysis 7 including the interrelatedness among the various healthcare 8 9 programs in order to ascertain effectiveness toward, and 10 ultimate impact on, clients. Beginning July 1, 2005, the 11 Department of Healthcare and Family Services (formerly 12 Department of Public Aid) shall supply quarterly reports to the Commission on Government Forecasting 13 and Accountability 14 detailing progress toward this mandate.

15 <u>(c) The Department of Healthcare and Family Services shall</u> 16 <u>integrate into its data warehouse data collected and housed at</u> 17 <u>the Illinois Department of Public Health and the Illinois</u> 18 <u>Department of Human Services that pertains to maternal and</u> 19 <u>child health, including, but not limited to, the following data</u> 20 <u>sets:</u>
