AN ACT concerning State government.

## Be it enacted by the People of the State of Illinois, 2 represented in the General Assembly: 3

4 Section 5. The Personnel Code is amended by changing 5 Section 4d as follows:

(20 ILCS 415/4d) (from Ch. 127, par. 63b104d) 6

7 Sec. 4d. Partial exemptions. The following positions in 8 State service are exempt from jurisdictions A, B, and C to the 9 extent stated for each, unless those jurisdictions are extended as provided in this Act: 10

11 (1)In each department, board or commission that now 12 maintains or may hereafter maintain a major administrative 13 division, service or office in both Sangamon County and Cook 14 County, 2 private secretaries for the director or chairman thereof, one located in the Cook County office and the other 15 16 located in the Sangamon County office, shall be exempt from 17 jurisdiction B; in all other departments, boards and commissions one private secretary for the director or chairman 18 19 thereof shall be exempt from jurisdiction B. Τn all 20 departments, boards and commissions one confidential assistant 21 for the director or chairman thereof shall be exempt from 22 jurisdiction B. This paragraph is subject to such modifications or waiver of the exemptions as may be necessary to assure the 23

continuity of federal contributions in those agencies
supported in whole or in part by federal funds.

3 (2) The resident administrative head of each State 4 charitable, penal and correctional institution, the chaplains 5 thereof, and all member, patient and inmate employees are 6 exempt from jurisdiction B.

Commission, 7 (3) The Civil Service upon written 8 recommendation of the Director of Central Management Services, 9 shall exempt from jurisdiction B other positions which, in the involve either 10 judgment of the Commission, principal 11 administrative responsibility for the determination of policy 12 or principal administrative responsibility for the way in which 13 policies are carried out, except positions in agencies which receive federal funds if such exemption is inconsistent with 14 15 federal requirements, and except positions in agencies 16 supported in whole by federal funds.

(4) All beauticians and teachers of beauty culture and teachers of barbering, and all positions heretofore paid under Section 1.22 of "An Act to standardize position titles and salary rates", approved June 30, 1943, as amended, shall be exempt from jurisdiction B.

(5) Licensed attorneys in positions as legal or technical advisors, positions in the Department of Natural Resources requiring incumbents to be either a registered professional engineer or to hold a bachelor's degree in engineering from a recognized college or university, licensed physicians in SB3215 Engrossed - 3 - LRB096 17986 HLH 33357 b

positions of medical administrator or physician or physician 1 2 specialist (including psychiatrists), and registered nurses (except those registered nurses employed by the Department of 3 4 Public Health), except those in positions in agencies which 5 receive federal funds if such exemption is inconsistent with 6 federal requirements and except those in positions in agencies 7 supported in whole by federal funds, are exempt from 8 jurisdiction B only to the extent that the requirements of 9 Section 8b.1, 8b.3 and 8b.5 of this Code need not be met.

10 (6) All positions established outside the geographical 11 limits of the State of Illinois to which appointments of other 12 than Illinois citizens may be made are exempt from jurisdiction 13 B.

14 (7) Staff attorneys reporting directly to individual
15 Commissioners of the Illinois Workers' Compensation Commission
16 are exempt from jurisdiction B.

17 (8) Persons having specialized and advanced training and experience in information technology deployment and support, 18 19 including specialized and advanced training and experience in 20 design, operation, or management of computer hardware, software telecommunications, or wide-area networks, that is 21 22 specifically required by the position description within the 23 bureau of the Department of Central Management Services that is 24 responsible for State information technology and 25 telecommunications systems, or persons maintaining an industry-recognized certification in information technology 26

SB3215 Engrossed - 4 - LRB096 17986 HLH 33357 b 1 that is specifically required by the position description with the bureau of the Department of Central Management Services 2 3 that is responsible for State information technology and telecommunications systems, are exempt from jurisdiction B 4 5 only to the extent that the requirements of Sections 8b.1, 6 8b.3, and 8b.5 of this Code need not be met. This paragraph (8) 7 is no longer operative after December 31, 2012. 8 (Source: P.A. 93-721, eff. 1-1-05.)
