1 AMENDMENT TO SENATE BILL 3215 2 AMENDMENT NO. . Amend Senate Bill 3215, AS AMENDED, by replacing everything after the enacting clause with the 3 4 following: 5 "Section 5. The Personnel Code is amended by changing 6 Section 4d as follows: 7 (20 ILCS 415/4d) (from Ch. 127, par. 63b104d) 8 Sec. 4d. Partial exemptions. The following positions in 9 State service are exempt from jurisdictions A, B, and C to the 10 extent stated for each, unless those jurisdictions are extended as provided in this Act: 11 12 (1) In each department, board or commission that now maintains or may hereafter maintain a major administrative 13 14 division, service or office in both Sangamon County and Cook 15 County, 2 private secretaries for the director or chairman

thereof, one located in the Cook County office and the other

- located in the Sangamon County office, shall be exempt from all other jurisdiction B: in departments, boards commissions one private secretary for the director or chairman thereof shall be exempt from jurisdiction В. In departments, boards and commissions one confidential assistant for the director or chairman thereof shall be exempt from jurisdiction B. This paragraph is subject to such modifications or waiver of the exemptions as may be necessary to assure the continuity of federal contributions in those agencies supported in whole or in part by federal funds.
 - (2) The resident administrative head of each State charitable, penal and correctional institution, the chaplains thereof, and all member, patient and inmate employees are exempt from jurisdiction B.
 - The Civil Service Commission, upon (3) recommendation of the Director of Central Management Services, shall exempt from jurisdiction B other positions which, in the the Commission, involve either judgment of principal administrative responsibility for the determination of policy or principal administrative responsibility for the way in which policies are carried out, except positions in agencies which receive federal funds if such exemption is inconsistent with federal requirements, and except positions in supported in whole by federal funds.
 - (4) All beauticians and teachers of beauty culture and teachers of barbering, and all positions heretofore paid under

- 2 salary rates", approved June 30, 1943, as amended, shall be
- 3 exempt from jurisdiction B.
- 4 (5) Licensed attorneys in positions as legal or technical
- 5 advisors, positions in the Department of Natural Resources
- 6 requiring incumbents to be either a registered professional
- 7 engineer or to hold a bachelor's degree in engineering from a
- 8 recognized college or university, licensed physicians in
- 9 positions of medical administrator or physician or physician
- 10 specialist (including psychiatrists), and registered nurses
- 11 (except those registered nurses employed by the Department of
- 12 Public Health), except those in positions in agencies which
- 13 receive federal funds if such exemption is inconsistent with
- 14 federal requirements and except those in positions in agencies
- 15 supported in whole by federal funds, are exempt from
- jurisdiction B only to the extent that the requirements of
- 17 Section 8b.1, 8b.3 and 8b.5 of this Code need not be met.
- 18 (6) All positions established outside the geographical
- limits of the State of Illinois to which appointments of other
- than Illinois citizens may be made are exempt from jurisdiction

- 22 (7) Staff attorneys reporting directly to individual
- 23 Commissioners of the Illinois Workers' Compensation Commission
- 24 are exempt from jurisdiction B.
- 25 <u>(8) Persons having specialized and advanced training and</u>
- 26 experience in information technology deployment and support,

- 1 including specialized and advanced training and experience in design, operation, or management of computer hardware, 2 software telecommunications, or wide-area networks, that is 3 4 specifically required by the position description within the 5 bureau of the Department of Central Management Services that is 6 responsible for State information technology and telecommunications systems, or persons maintaining an 7 industry-recognized certification in information technology 8 9 that is specifically required by the position description with 10 the bureau of the Department of Central Management Services 11 that is responsible for State information technology and telecommunications systems, are exempt from jurisdiction B 12 only to the extent that the requirements of Sections 8b.1, 13 14 8b.3, and 8b.5 of this Code need not be met. This paragraph (8) 15 is no longer operative after December 31, 2012. 16 (Source: P.A. 93-721, eff. 1-1-05.)
