A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named sums, or so much thereof
6 as may be necessary, respectively, for the objects and
7 purposes hereinafter named, are appropriated to meet the
8 ordinary and contingent expenses of the Illinois Arts
9 Council:

2 Section 10. The following named sums, or so much thereof
3 as may be necessary, respectively, for the objects and
4 purposes hereinafter named, are appropriated to the Illinois
5 Arts Council to enhance the cultural environment in Illinois:

8 Arts Organizations2,901,200

9 For Grants and Financial Assistance for

11 For Grants and Financial Assistance for

23 Section 15. The sum of \$322,800, or so much thereof as

1 may be necessary, is appropriated from the General Revenue
2 Fund to the Illinois Arts Council for the purpose of funding
3 administrative and grant expenses associated with humanities
4 programs and related activities.

5 Section 20 The amount of \$1,890,300 or so much thereof
6 as may be necessary is appropriated from the General Revenue
7 Fund to the Illinois Arts Council for grants to certain
8 public radio and television stations and related
9 administrative expenses, pursuant to the Public Radio and
10 Television Grant Act.

11 Section 99. Effective date. This Act takes effect July 1,
12 2010.
