Amend House Bill 1070, AS AMENDED, by 3 replacing everything after the enacting clause with the 4 following: "Section 5. The Illinois Vehicle Code is amended by 5 6 changing Section 3-600 and adding Section 3-600.1 as follows: 7 (625 ILCS 5/3-600) (from Ch. 95 1/2, par. 3-600) Sec. 3-600. Requirements for issuance of special plates. 8 (a) The Secretary of State shall issue only special plates 9 10 that have been authorized by the General Assembly. The Secretary of State shall not issue a series of special plates 11 12 unless applications, as prescribed by the Secretary, have been 13 received for 10,000 plates of that series; except that the Secretary of State may prescribe some other required number of 14 15 applications if that number is sufficient to pay for the total cost of designing, manufacturing and issuing the special 16

1 license plate.

2 (b) The Secretary of State, upon issuing a new series of 3 special license plates, shall notify all law enforcement 4 officials of the design, color and other special features of 5 the special license plate series.

6 (c) This Section shall not apply to special license plate 7 categories in existence on the effective date of this 8 amendatory Act of 1990, or to the Secretary of State's 9 discretion as established in Section 3-611.

10 <u>(d) Beginning with the 2013 registration year, the</u> 11 provisions of Section 3-600.1 control the issuance and 12 <u>re-issuance of special plates.</u>

15 <u>Sec. 3-600.1. Special plates; issuance and reissuance.</u>

(a) Beginning with the 2013 registration year, an 16 organization may apply to the Secretary of State and the 17 18 Secretary may authorize the issuance of a new series of special 19 plates. The Secretary shall not issue a series of special plates unless enough applications, as prescribed by the 20 21 Secretary, have been received to pay for the total cost of designing, manufacturing, and issuing the special license 22 23 plate.

24 <u>(b) The Secretary of State, upon issuing a new series of</u> 25 <u>special license plates, shall notify all law enforcement</u>

1	officials of the design, color, and other special features of
2	the special license plate series.
3	(c) This Section shall not affect the issuance or
4	reissuance of special license plate categories in existence on
5	the effective date of this amendatory Act of the 97th General
6	Assembly, or the Secretary of State's discretion under Section
7	<u>3-611 of this Code.</u> ".
