## 2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

4 Section 5. The Care of Students with Diabetes Act is 5 amended by changing Section 25 as follows:

6 (105 ILCS 145/25)

Sec. 25. Training for school employees and delegated careaides.

9 (a) In schools that have a student with diabetes, all 10 school employees shall receive training in the basics of 11 diabetes care, how to identify when a student with diabetes 12 needs immediate or emergency medical attention, and whom to 13 contact in the case of an emergency during <del>a</del> regular <u>inservice</u> 14 <u>in service</u> training <u>under as provided for by</u> Section <u>3-11</u> 15 <u>10-22.39</u> of the School Code.

16 (b) Delegated care aides shall be trained to perform the 17 tasks necessary to assist a student with diabetes in accordance 18 with his or her diabetes care plan, including training to do 19 the following:

(1) check blood glucose and record results;

(2) recognize and respond to the symptoms of
 hypoglycemia according to the diabetes care plan;

23 (3) recognize and respond to the symptoms of

hyperglycemia according to the diabetes care plan;

2 (4) estimate the number of carbohydrates in a snack or
3 lunch;

4 (5) administer insulin according to the student's 5 diabetes care plan and keep a record of the amount 6 administered; and

7 (6) respond in an emergency, including how to
8 administer glucagon and call 911.

(c) The school district shall coordinate staff training.

10 (d) Initial training of a delegated care aide shall be 11 provided by a licensed healthcare provider with expertise in 12 diabetes or a certified diabetic educator and individualized by a student's parent or quardian. Training must be consistent 13 14 with the guidelines provided by the U.S. Department of Health 15 and Human Services in the guide for school personnel entitled "Helping the Student with Diabetes Succeed". The training shall 16 17 be updated when the diabetes care plan is changed and at least 18 annually.

(e) School nurses, where available, or health care
providers may provide technical assistance or consultation or
both to delegated care aides.

(f) An information sheet shall be provided to any school employee who transports a student for school-sponsored activities. It shall identify the student with diabetes, identify potential emergencies that may occur as a result of the student's diabetes and the appropriate responses to such
