(b) If it appears by the returns of the election that a

1 majority of the votes of the township cast on the question of the continuance of township organization are against 2 continuance, then the office of Township Supervisor and the 3 4 office of Township Assessor shall cease in the township at the 5 next January 1 after the proposition was approved. If the 6 office of Township Supervisor ceases, then the coterminous municipality shall assume the duties of Township Supervisor. If 7 the office of Township Assessor ceases, then the coterminous 8 9 municipality shall assume the duties of the Township Assessor 10 under the Property Tax Code and the Public Health District Act. 11 (c) The coterminous municipality shall assume all taxing 12 authority of the township abolished under this Section. For purposes of distribution of revenue, the coterminous 13 14 municipality shall assume the powers, duties, and obligations 15 of the township. 16 (d) Upon discontinuance of township organization, the records of the township shall be deposited in the city clerk's 17 office. The coterminous municipality may close up all 18 19 unfinished business of the township and sell and dispose of any of the property belonging to the township, as fully as might 20 21 have been done by the township itself, for benefit of the 22 inhabitants of the municipality. (e) Nothing in this Section shall prevent the coterminous 23 24 municipality from entering into an intergovernmental agreement 25 or contract to provide for general assistance or property
