Amends the Uniform Peace Officers' Disciplinary Act. Requires that any sworn complaint against a peace officer that contains false information shall be presented to the appropriate State's Attorney for a determination of prosecution. Effective immediately.

# 2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Uniform Peace Officers' Disciplinary Act is
amended by changing Section 3.8 as follows:

Sec. 3.8. Admissions; counsel; verified complaint.

8 (a) No officer shall be interrogated without first being 9 advised in writing that admissions made in the course of the 10 interrogation may be used as evidence of misconduct or as the 11 basis for charges seeking suspension, removal, or discharge; 12 and without first being advised in writing that he or she has 13 the right to counsel of his or her choosing who may be present 14 to advise him or her at any stage of any interrogation.

(b) Anyone filing a complaint against a sworn peace officer must have the complaint supported by a sworn affidavit. <u>Any</u> <u>complaint, having been supported by a sworn affidavit, and</u> <u>having been found, in total or in part, to contain false</u> <u>information, shall be presented to the appropriate State's</u> <u>Attorney for a determination of prosecution.</u>
