A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much
6 thereof as may be necessary, respectively, are appropriated
7 for the ordinary and contingent expenses of the Office of the
8 State Fire Marshal, as follows:

20 Section 10. The sum of \$680,900, or so much thereof as
 21 may be necessary, is appropriated from the Fire Prevention
 22 Fund to the Office of the State Fire Marshal for costs and
 23 expenses related to or in support of a public safety shared
 24 services center.

1 Section 20. The sum of \$200,000, or so much thereof as
 2 may be necessary, is appropriated from the Illinois
 3 Firefighters' Memorial Fund to the Office of the State Fire
 4 Marshal for expenses related to the maintenance of the
 5 Illinois Firefighters' Memorial, holding the annual Fallen
 6 Firefighter Ceremony, and other expenses as allowed under
 7 Public Act 91-0832.

8 Section 25. The following named amounts, or so much
 9 thereof as may be necessary, respectively, are appropriated
 10 to the Office of the State Fire Marshal as follows:

11 Payable from the Fire Prevention Fund:

12 For expenses of new fire chiefs training and training
 13 audits175,000

14 For Expenses of the Risk Watch/Remember
 15 When program10,000

16 For expenses related to fire prevention training25,000

17 Payable from the Fire Prevention Division Fund:

18 For Expenses of the U.S. Resource
 19 Conservation and Recovery Act
 20 Underground Storage Program1,787,000

21 Section 30. The following named amounts, or so much
 22 thereof as may be necessary, respectively, are appropriated

1 for the ordinary and contingent expenses of the Office of the
2 State Fire Marshal, as follows:

4 Payable from the Fire Prevention Fund:

13 Section 35. The sum of \$1,000, or so much thereof as may
14 be necessary, is appropriated from the Fire Prevention Fund
15 to the Office of the State Fire Marshal for grants available
16 for the development of new fire districts.

17 Section 40. The sum of \$550,000, or so much thereof as
18 may be necessary, is appropriated from the Underground
19 Storage Tank Fund to the Office of the State Fire Marshal for
20 a grant to the City of Chicago for Administrative Costs
21 incurred as a result of the State's Underground Storage
22 Program.

1 Section 45. The sum of \$125,000, or so much thereof as
2 may be necessary, is appropriated from the Fire Prevention
3 Fund to the Office of the State Fire Marshal for grants
4 available for costs and services related to ILEAS/MABAS
5 administration.

7 Section 50. The sum of \$300,000, or so much thereof as
8 may be necessary, is appropriated from the Fire Prevention
9 Division Fund to the Office of the State Fire Marshal for
10 assistance to firefighters grant for smoke detectors for the
11 deaf and hard of hearing.

12 Section 99. Effective date. This Act takes effect July 1,
13 2011.
