SYNOPSIS AS INTRODUCED:

410 ILCS 325/9

from Ch. 111 1/2, par. 7409

Amends the Illinois Sexually Transmissible Disease Control Act. Provides that the Department of Public Health, in consultation with the Department of Corrections and local health departments, shall develop and implement written procedures that establish a process for confidentially notifying and recommending sexually transmissible disease testing of (1) contacts in the community of a prisoner diagnosed with a sexually transmissible disease and (2) prisoners whose contacts in the community or in the prison have been diagnosed with a sexually transmissible disease. Sets forth requirements concerning the process. Effective immediately.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Illinois Sexually Transmissible Disease
Control Act is amended by changing Section 9 as follows:

6 (410 ILCS 325/9) (from Ch. 111 1/2, par. 7409)

7 Sec. 9. Prisoners.

(a) The Department and its authorized representatives may, 8 9 at its discretion, enter any State, county or municipal detention facility to interview, examine and treat any prisoner 10 for a sexually transmissible disease. Any such State, county or 11 12 detention facility shall cooperate with municipal the 13 Department and its authorized representative to provide such 14 space as is necessary for the examination and treatment of all prisoners suffering from or suspected of having a sexually 15 16 transmissible disease.

(b) Nothing in this Section shall be construed as relieving the Department of Corrections or any county or municipality of their primary responsibility for providing medical treatment for prisoners under their jurisdiction, including treatment for sexually transmissible diseases.

(c) Any person who knowingly or maliciously disseminatesany false information or report concerning the existence of any

3 (d) The Department, in consultation with the Department of 4 Corrections and local health departments, shall develop and implement written procedures that establish a process for 5 6 confidentially notifying and recommending sexually transmissible disease testing of (1) contacts in the community 7 of a prisoner diagnosed with a sexually transmissible disease 8 9 and (2) prisoners whose contacts in the community or in the prison have been diagnosed with a sexually transmissible 10 11 disease. The process shall include a single point of contact in each Department for the notification. The process shall be in 12 accordance with Sections 3, 5, and 8 of this Act. 13
