1 AMENDMENT TO HOUSE BILL 4692 2 AMENDMENT NO. . Amend House Bill 4692 by replacing everything after the enacting clause with the following: 3 "Section 5. The Illinois Vehicle Code is amended by 4 5 changing Section 6-110 as follows: 6 (625 ILCS 5/6-110) (from Ch. 95 1/2, par. 6-110) 7 Sec. 6-110. Licenses issued to drivers. (a) The Secretary of State shall issue to every qualifying 8 applicant a driver's license as applied for, which license 9 10 shall bear a distinguishing number assigned to the licensee, 11 the legal name, signature, zip code, date of birth, residence 12 address, and a brief description of the licensee. Licenses issued shall also indicate the classification and 13 14 the restrictions under Section 6-104 of this Code. The

Secretary may adopt rules to establish informational

restrictions that can be placed on the driver's license

- A driver's license issued may, in the discretion of the Secretary, include a suitable photograph of a type prescribed by the Secretary.
- 5 (a-1) If the licensee is less than 18 years of age, unless 6 one of the exceptions in subsection (a-2) apply, the license 7 shall, as a matter of law, be invalid for the operation of any 8 motor vehicle during the following times:
 - (A) Between 11:00 p.m. Friday and 6:00 a.m. Saturday;
- 10 (B) Between 11:00 p.m. Saturday and 6:00 a.m. on 11 Sunday; and
- 12 (C) Between 10:00 p.m. on Sunday to Thursday, 13 inclusive, and 6:00 a.m. on the following day.
- 14 (a-2) The driver's license of a person under the age of 18 15 shall not be invalid as described in subsection (a-1) of this 16 Section if the licensee under the age of 18 was:
- 17 (1) accompanied by the licensee's parent or guardian or 18 other person in custody or control of the minor;
- 19 (2) on an errand at the direction of the minor's parent 20 or guardian, without any detour or stop;
 - (3) in a motor vehicle involved in interstate travel;
- 22 (4) going to or returning home from an employment 23 activity, without any detour or stop;
 - (5) involved in an emergency;
- 25 (6) going to or returning home from, without any detour 26 or stop, an official school, religious, or other

- (7) exercising First Amendment rights protected by the United States Constitution, such as the free exercise of religion, freedom of speech, and the right of assembly; or
- (8) married or had been married or is an emancipated minor under the Emancipation of Minors Act.
- (a-2.5) The driver's license of a person who is 17 years of age and has been licensed for at least 12 months is not invalid as described in subsection (a-1) of this Section while the licensee is participating as an assigned driver in a Safe Rides program that meets the following criteria:
 - (1) the program is sponsored by the Boy Scouts of America or another national public service organization; and
- (2) the sponsoring organization carries liability insurance covering the program.
- (a-3) If a graduated driver's license holder over the age of 18 committed an offense against traffic regulations governing the movement of vehicles or any violation of Section 6-107 or Section 12-603.1 of this Code in the 6 months prior to the graduated driver's license holder's 18th birthday, and was subsequently convicted of the offense, the provisions of

subsection (a-1) shall continue to apply until such time as a period of 6 consecutive months has elapsed without an additional violation and subsequent conviction of an offense against traffic regulations governing the movement of vehicles

or Section 6-107 or Section 12-603.1 of this Code.

(a-4) If an applicant for a driver's license or instruction permit has a current identification card issued by the Secretary of State, the Secretary may require the applicant to utilize the same residence address and name on the identification card, driver's license, and instruction permit records maintained by the Secretary. The Secretary may promulgate rules to implement this provision.

(b) Until the Secretary of State establishes a First Person Consent organ and tissue donor registry under Section 6-117 of this Code, the Secretary of State shall provide a format on the reverse of each driver's license issued which the licensee may use to execute a document of gift conforming to the provisions of the Illinois Anatomical Gift Act. The format shall allow the licensee to indicate the gift intended, whether specific organs, any organ, or the entire body, and shall accommodate the signatures of the donor and 2 witnesses. The Secretary shall also inform each applicant or licensee of this format, describe the procedure for its execution, and may offer the necessary witnesses; provided that in so doing, the Secretary shall advise the applicant or licensee that he or she is under no compulsion to execute a document of gift. - 1 explaining this method of executing an anatomical gift document shall be given to each applicant or licensee. The brochure 2 3 shall advise the applicant or licensee that he or she is under 4 no compulsion to execute a document of gift, and that he or she 5 may wish to consult with family, friends or clergy before doing so. The Secretary of State may undertake additional efforts, 6 7 including education and awareness activities, to promote organ 8 and tissue donation.
 - (c) The Secretary of State shall designate on each driver's license issued a space where the licensee may place a sticker or decal of the uniform size as the Secretary may specify, which sticker or decal may indicate in appropriate language that the owner of the license carries an Emergency Medical Information Card.
 - The sticker may be provided by any person, hospital, school, medical group, or association interested in assisting in implementing the Emergency Medical Information Card, but shall meet the specifications as the Secretary may by rule or regulation require.
 - (d) The Secretary of State shall designate on each driver's license issued a space where the licensee may indicate his blood type and RH factor.
- 23 (e) The Secretary of State shall provide that each original 24 or renewal driver's license issued to a licensee under 21 years 25 of age shall be of a distinct nature from those driver's 26 licenses issued to individuals 21 years of age and older. The

- 1 color designated for driver's licenses for licensees under 21
- 2 years of age shall be at the discretion of the Secretary of
- 3 State.
- 4 (e-1) The Secretary shall provide that each driver's
- 5 license issued to a person under the age of 21 displays the
- date upon which the person becomes 18 years of age and the date
- 7 upon which the person becomes 21 years of age.
- 8 (f) The Secretary of State shall inform all Illinois
- 9 licensed commercial motor vehicle operators of the
- 10 requirements of the Uniform Commercial Driver License Act,
- 11 Article V of this Chapter, and shall make provisions to insure
- 12 that all drivers, seeking to obtain a commercial driver's
- license, be afforded an opportunity prior to April 1, 1992, to
- 14 obtain the license. The Secretary is authorized to extend
- driver's license expiration dates, and assign specific times,
- dates and locations where these commercial driver's tests shall
- 17 be conducted. Any applicant, regardless of the current
- 18 expiration date of the applicant's driver's license, may be
- 19 subject to any assignment by the Secretary. Failure to comply
- 20 with the Secretary's assignment may result in the applicant's
- 21 forfeiture of an opportunity to receive a commercial driver's
- license prior to April 1, 1992.
- 23 (g) The Secretary of State shall designate on a driver's
- license issued, a space where the licensee may indicate that he
- 25 or she has drafted a living will in accordance with the
- 26 Illinois Living Will Act or a durable power of attorney for

- 1 health care in accordance with the Illinois Power of Attorney
- 2 Act.
- 3 (g-1) The Secretary of State, in his or her discretion, may
- 4 designate on each driver's license issued a space where the
- 5 licensee may place a sticker or decal, issued by the Secretary
- of State, of uniform size as the Secretary may specify, that
- 7 shall indicate in appropriate language that the owner of the
- 8 license has renewed his or her driver's license.
- 9 (h) A person who acts in good faith in accordance with the
- 10 terms of this Section is not liable for damages in any civil
- action or subject to prosecution in any criminal proceeding for
- 12 his or her act.
