1 AN ACT concerning transportation.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Illinois Vehicle Code is amended by changing
Section 6-110 as follows:

6 (625 ILCS 5/6-110) (from Ch. 95 1/2, par. 6-110)

7 Sec. 6-110. Licenses issued to drivers.

8 (a) The Secretary of State shall issue to every qualifying 9 applicant a driver's license as applied for, which license 10 shall bear a distinguishing number assigned to the licensee, 11 the legal name, signature, zip code, date of birth, residence 12 address, and a brief description of the licensee.

Licenses issued shall also indicate the classification and the restrictions under Section 6-104 of this Code. <u>The</u> <u>Secretary may adopt rules to establish informational</u> <u>restrictions that can be placed on the driver's license</u> <u>regarding specific conditions of the licensee</u>.

A driver's license issued may, in the discretion of the Secretary, include a suitable photograph of a type prescribed by the Secretary.

(a-1) If the licensee is less than 18 years of age, unless
one of the exceptions in subsection (a-2) apply, the license
shall, as a matter of law, be invalid for the operation of any

motor vehicle during the following times: 1 2 (A) Between 11:00 p.m. Friday and 6:00 a.m. Saturday; 3 Between 11:00 p.m. Saturday and 6:00 a.m. on (B) Sunday; and 4 5 (C) Between 10:00 p.m. on Sunday to Thursday, 6 inclusive, and 6:00 a.m. on the following day. 7 (a-2) The driver's license of a person under the age of 18 shall not be invalid as described in subsection (a-1) of this 8 9 Section if the licensee under the age of 18 was: 10 (1) accompanied by the licensee's parent or quardian or 11 other person in custody or control of the minor; 12 (2) on an errand at the direction of the minor's parent 13 or guardian, without any detour or stop; (3) in a motor vehicle involved in interstate travel; 14 15 (4) going to or returning home from an employment 16 activity, without any detour or stop; 17 (5) involved in an emergency; (6) going to or returning home from, without any detour 18 19 official school, religious, or stop, an or other 20 recreational activity supervised by adults and sponsored 21 а government or governmental agency, civic by а 22 organization, or another similar entity that takes 23 responsibility for the licensee, without any detour or 24 stop; 25 (7) exercising First Amendment rights protected by the

religion, freedom of speech, and the right of assembly; or

(8) married or had been married or is an emancipated minor under the Emancipation of Minors Act.

4 (a-2.5) The driver's license of a person who is 17 years of 5 age and has been licensed for at least 12 months is not invalid 6 as described in subsection (a-1) of this Section while the 7 licensee is participating as an assigned driver in a Safe Rides 8 program that meets the following criteria:

9 (1) the program is sponsored by the Boy Scouts of 10 America or another national public service organization; 11 and

12 (2) the sponsoring organization carries liability13 insurance covering the program.

14 (a-3) If a graduated driver's license holder over the age 15 of 18 committed an offense against traffic regulations 16 governing the movement of vehicles or any violation of Section 17 6-107 or Section 12-603.1 of this Code in the 6 months prior to the graduated driver's license holder's 18th birthday, and was 18 19 subsequently convicted of the offense, the provisions of 20 subsection (a-1) shall continue to apply until such time as a period of 6 consecutive months has elapsed without an 21 22 additional violation and subsequent conviction of an offense 23 against traffic regulations governing the movement of vehicles or Section 6-107 or Section 12-603.1 of this Code. 24

(a-4) If an applicant for a driver's license or instruction
 permit has a current identification card issued by the

Secretary of State, the Secretary may require the applicant to 1 2 residence utilize the same address and name on the identification card, driver's license, and instruction permit 3 records maintained by the Secretary. The Secretary may 4 5 promulgate rules to implement this provision.

6 (b) Until the Secretary of State establishes a First Person 7 Consent organ and tissue donor registry under Section 6-117 of 8 this Code, the Secretary of State shall provide a format on the 9 reverse of each driver's license issued which the licensee may 10 use to execute a document of gift conforming to the provisions 11 of the Illinois Anatomical Gift Act. The format shall allow the 12 licensee to indicate the gift intended, whether specific organs, any organ, or the entire body, and shall accommodate 13 14 the signatures of the donor and 2 witnesses. The Secretary 15 shall also inform each applicant or licensee of this format, 16 describe the procedure for its execution, and may offer the 17 necessary witnesses; provided that in so doing, the Secretary shall advise the applicant or licensee that he or she is under 18 19 no compulsion to execute a document of gift. A brochure 20 explaining this method of executing an anatomical gift document shall be given to each applicant or licensee. The brochure 21 22 shall advise the applicant or licensee that he or she is under 23 no compulsion to execute a document of gift, and that he or she may wish to consult with family, friends or clergy before doing 24 25 so. (c) The Secretary of State shall designate on each driver's
license issued a space where the licensee may place a sticker
or decal of the uniform size as the Secretary may specify,
which sticker or decal may indicate in appropriate language
that the owner of the license carries an Emergency Medical
Information Card.

8 The sticker may be provided by any person, hospital, 9 school, medical group, or association interested in assisting 10 in implementing the Emergency Medical Information Card, but 11 shall meet the specifications as the Secretary may by rule or 12 regulation require.

13 (d) The Secretary of State shall designate on each driver's 14 license issued a space where the licensee may indicate his 15 blood type and RH factor.

(e) The Secretary of State shall provide that each original
or renewal driver's license issued to a licensee under 21 years
of age shall be of a distinct nature from those driver's
licenses issued to individuals 21 years of age and older. The
color designated for driver's licenses for licensees under 21
years of age shall be at the discretion of the Secretary of
State.

(e-1) The Secretary shall provide that each driver's license issued to a person under the age of 21 displays the date upon which the person becomes 18 years of age and the date upon which the person becomes 21 years of age. HB4692 Enrolled - 6 - LRB097 16560 HEP 61732 b

The Secretary of State shall inform all Illinois 1 (f) 2 licensed commercial motor vehicle operators of the requirements of the Uniform Commercial Driver License Act, 3 Article V of this Chapter, and shall make provisions to insure 4 5 that all drivers, seeking to obtain a commercial driver's 6 license, be afforded an opportunity prior to April 1, 1992, to 7 obtain the license. The Secretary is authorized to extend 8 driver's license expiration dates, and assign specific times, 9 dates and locations where these commercial driver's tests shall 10 be conducted. Any applicant, regardless of the current 11 expiration date of the applicant's driver's license, may be 12 subject to any assignment by the Secretary. Failure to comply 13 with the Secretary's assignment may result in the applicant's forfeiture of an opportunity to receive a commercial driver's 14 license prior to April 1, 1992. 15

(g) The Secretary of State shall designate on a driver's license issued, a space where the licensee may indicate that he or she has drafted a living will in accordance with the Illinois Living Will Act or a durable power of attorney for health care in accordance with the Illinois Power of Attorney Act.

(g-1) The Secretary of State, in his or her discretion, may designate on each driver's license issued a space where the licensee may place a sticker or decal, issued by the Secretary of State, of uniform size as the Secretary may specify, that shall indicate in appropriate language that the owner of the HB4692 Enrolled - 7 - LRB097 16560 HEP 61732 b

1 license has renewed his or her driver's license.

2 (h) A person who acts in good faith in accordance with the 3 terms of this Section is not liable for damages in any civil 4 action or subject to prosecution in any criminal proceeding for 5 his or her act.
