

## 97TH GENERAL ASSEMBLY State of Illinois 2011 and 2012 HB5075

Introduced 2/7/2012, by Rep. Robyn Gabel

## SYNOPSIS AS INTRODUCED:

30 ILCS 105/5.811 new 625 ILCS 5/3-699 new

Amends the State Finance Act and Illinois Vehicle Code to provide for the issuance of Illinois Nurses license plates. Creates the Illinois Nurses Foundation Fund as a special fund in the State treasury. Provides that the applicant shall pay an additional fee of \$35 for original issuance of the plates, of which \$20 shall be deposited into the Illinois Nurses Foundation Fund and \$15 shall be deposited into the Secretary of State Special License Plate Fund. Provides that an additional fee of \$22 shall be charged for each renewal, of which \$20 shall be deposited into the Illinois Nurses Foundation Fund and \$2 shall be deposited into the Secretary of State Special License Plate Fund. Provides that moneys in the Illinois Nurses Foundation Fund shall be paid as grants to the Illinois Nurses Foundation, to promote the health of the public by advancing the nursing profession in Illinois.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- 4 Section 5. The State Finance Act is amended by adding
- 5 Section 5.811 as follows:
- 6 (30 ILCS 105/5.811 new)
- 7 Sec. 5.811. The Illinois Nurses Foundation Fund.
- 8 Section 10. The Illinois Vehicle Code is amended by adding
- 9 Section 3-699 as follows:
- 10 (625 ILCS 5/3-699 new)
- 11 Sec. 3-699. Illinois Nurses license plates.
- 12 (a) The Secretary, upon receipt of an application made in
- 13 the form prescribed by the Secretary, may issue special
- 14 registration plates designated as Illinois Nurses license
- 15 plates. The special plates issued under this Section shall be
- 16 affixed only to passenger vehicles of the first division and
- 17 motor vehicles of the second division weighing not more than
- 18 8,000 pounds. Plates issued under this Section shall expire
- 19 <u>according to the multi-year procedure established by Section</u>
- 20 3-414.1 of this Code.
- 21 (b) The design and color of the plates is wholly within the

- discretion of the Secretary. The Secretary may allow the plates
- 2 <u>to be issued as vanity plates or personalized under Section</u>
- 3 <u>3-405.1 of the Code. The Secretary shall prescribe stickers or</u>
- 4 decals as provided under Section 3-412 of this Code.
- 5 (c) An applicant for the special plate shall be charged a
- 6 \$35 fee for original issuance in addition to the appropriate
- 7 registration fee. Of this fee, \$20 shall be deposited into the
- 8 Illinois Nurses Foundation Fund and \$15 shall be deposited into
- 9 the Secretary of State Special License Plate Fund, to be used
- 10 by the Secretary to help defray administrative processing
- 11 costs.
- 12 For each registration renewal period, a \$22 fee, in
- addition to the appropriate registration fee, shall be charged.
- 14 Of this fee, \$20 shall be deposited into the Illinois Nurses
- 15 Foundation Fund and \$2 shall be deposited into the Secretary of
- 16 State Special License Plate Fund.
- 17 (d) The Illinois Nurses Foundation Fund is created as a
- 18 special fund in the State treasury. All money in the Illinois
- 19 Nurses Foundation Fund shall be paid, subject to appropriation
- 20 by the General Assembly and distribution by the Secretary, as
- 21 grants to the Illinois Nurses Foundation, to promote the health
- of the public by advancing the nursing profession in this
- 23 State.
