3. Beginning with the 1991 registration year,

All-terrain vehicles owned by counties, townships, or municipal corporations and used for law enforcement 6 7 purposes when the Manufacturer's Statement of Origin is 8 accompanied with a letter from the original manufacturer or 9 a manufacturer's franchised dealer stating that this 10 all-terrain vehicle has been converted to a street worthy 11 vehicle that meets the equipment requirements set forth in 12 Chapter 12 of this Code.

5. Beginning with the 2001 registration year, municipally-owned vehicles operated by or for any police department. These registration plates shall contain the designation "municipal police" and shall be numbered and distributed as prescribed by the Secretary of State.
