A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. The following named amounts, or so much
6 thereof as may be necessary, respectively, for the objects
7 and purposes hereinafter named, are appropriated to meet the
8 ordinary and contingent expenses of the Illinois Criminal
9 Justice Information Authority:

6 Section 5. The sum of \$2,424,000, or so much thereof as
7 may be necessary, is appropriated from the General Revenue
8 Fund to the Illinois Criminal Justice Information Authority
9 for awards and grants for the Adult Redeploy program.

10 Section 10. The sum of \$40,000,000, or so much thereof
11 as may be necessary, is appropriated from the Criminal
12 Justice Trust Fund to the Illinois Criminal Justice
13 Information Authority for awards and grants to local units of
14 government and non-profit organizations.

15 Section 15. The additional sum of \$1,771,800, or so much
16 thereof as may be necessary, is appropriated from the
17 Criminal Justice Trust Fund to the Illinois Criminal Justice
18 Information Authority for Violence Against Women awards and
19 grants to local units of government and non-profit
20 organizations in accordance with applicable laws and
21 regulations for the State portion of federal funds made
22 available by the American Recovery and Reinvestment Act of

1 2009.

2 Section 20. The additional sum of \$13,520,100, or so
3 much thereof as may be necessary, is appropriated from the
4 Criminal Justice Trust Fund to the Illinois Criminal Justice
5 Information Authority for Byrne/JAG awards and grants to
6 local units of government and non-profit organizations in
7 accordance with applicable laws and regulations for the State
8 portion of federal funds made available by the American
9 Recovery and Reinvestment Act of 2009.

10 Section 25. The sum of \$12,000,000, or so much thereof
11 as may be necessary, is appropriated from the Criminal
12 Justice Trust Fund to the Illinois Criminal Justice
13 Information Authority for awards and grants to state
14 agencies.

15 Section 30. The additional sum of \$250,000, or so much
16 thereof as may be necessary, is appropriated from the
17 Criminal Justice Trust Fund to the Illinois Criminal Justice
18 Information Authority for Violence Against Women awards and
19 grants to state agencies in accordance with applicable laws
20 and regulations for the State portion of federal funds made
21 available by the American Recovery and Reinvestment Act of
22 2009.

1 Section 35. The additional sum of \$8,650,000, or so much
 2 thereof as may be necessary, is appropriated from the
 3 Criminal Justice Trust Fund to the Illinois Criminal Justice
 4 Information Authority for Byrne/JAG awards and grants to
 5 state agencies in accordance with applicable laws and
 6 regulations for the State portion of federal funds made
 7 available by the American Recovery and Reinvestment Act of
 8 2009.

9 Section 40. The following named sums, or so much thereof
 10 as may be necessary, are appropriated to the Illinois
 11 Criminal Justice Information Authority for activities
 12 undertaken in support of federal assistance programs
 13 administered by units of state and local government and non-
 14 profit organizations:

22 Section 45. The following named amounts, or so much

1 thereof as may be necessary, are appropriated to the Illinois
 2 Criminal Justice Information Authority for awards and grants
 3 and other monies received from federal agencies, from other
 4 units of government, and from private/not-for-profit
 5 organizations for activities undertaken in support of
 6 investigating issues in criminal justice and for undertaking
 7 other criminal justice information projects:

13 Section 50. The following named amounts, or so much
 14 thereof as may be necessary, respectively, for the objects
 15 and purposes hereinafter named, are appropriated to the
 16 Illinois Criminal Justice Information Authority for awards,
 17 grants and operational support to implement the Motor Vehicle
 18 Theft Prevention Act:

9 Section 55. The sum of \$4,500,000, or so much thereof as
10 may be necessary, is appropriated from the Juvenile
11 Accountability Incentive Block Grant Trust Fund to the
12 Illinois Criminal Justice Information Authority for awards
13 and grants to state agencies and units of local government,
14 including operational expenses of the Authority in support of
15 the Juvenile Accountability Incentive Block Grant program.

16 Section 60. The sum of \$150,000, or so much thereof as
17 may be necessary, is appropriated from the Illinois State
18 Crime Stoppers Association Fund to the Illinois Criminal
19 Justice Information Authority for grants to enhance and
20 develop Crime Stoppers programs in Illinois.

21 Section 65. The following named amounts, or so much
22 thereof as may be necessary, respectively, for the objects

1 and purposes hereinafter named, are appropriated to the
 2 Illinois Criminal Justice Information Authority for the
 3 training of law enforcement personnel and services for
 4 families of homicide or murder:

5 Payable from the Death Penalty Abolition Fund:

18 Section 70. The sum of \$200,000, or so much thereof as
 19 may be necessary, is appropriated from the Prescription Pill
 20 and Drug Disposal Fund to the Illinois Criminal Justice
 21 Information Authority for the purpose of collection,
 22 transportation, and incineration of pharmaceuticals by local
 23 law enforcement agencies.

1 Section 99. Effective date. This Act takes effect July 1,
2 2012.
