HOUSE RESOLUTION

2 WHEREAS, On December 1, 2012, the Northern Illinois 3 University Huskies football team won the Mid-American 4 Conference championship in a tense 44-37 double-overtime 5 victory over Kent State; and

6 WHEREAS, With an undefeated conference record of 8-0, the 7 Huskies went on to finish their season with a dominant overall 8 record of 12-1; and

9 WHEREAS, On December 2, 2012, the Huskies learned that the 10 team will face the Florida State Seminoles on New Year's Day in 11 the 2013 Orange Bowl, becoming the first team from the 12 Mid-American Conference to earn a berth in a BCS bowl game; and

13 WHEREAS, After not winning the Mid-America Conference 14 championship since 1983, the Huskies have now won back-to-back 15 Mid-America Conference championships after their victory 16 against Kent State and their 2011 championship victory against 17 Ohio; and

18 WHEREAS, The team was led by junior quarterback Jordan 19 Lynch, who, with legitimate Heisman Trophy credentials passed 20 for 2,962 yards and 24 touchdowns, led the NCAA in rushing 21 yards and set the NCAA rushing record for quarterbacks with HR1333 -2- LRB097 23632 GRL 72696 r 1,771 yards, in addition to 19 touchdowns; and

2 WHEREAS, Northern Illinois University is nationally 3 recognized for the success of its student athletes on the field 4 and in the classroom; and

5 WHEREAS, A conference championship takes dedication from 6 all members and coaches on the roster, as well as all the 7 devoted Northern Illinois University students and Huskies 8 fans; therefore, be it

9 RESOLVED, ΒY THE HOUSE OF REPRESENTATIVES OF THE 10 NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we commend and applaud the 2012 Northern Illinois University 11 12 Huskies for their accomplishments during the 2012 season, for the talent and teamwork displayed on the field, for their 13 14 excellence and humility off the field, for the outstanding coaching staff leading team, and for becoming the first 15 Mid-America Conference team to earn a berth in a BCS bowl game 16 when the team plays the Florida State Seminoles in the Orange 17 Bowl on New Year's Day; and be it further 18
