Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- under this Section shall be affixed only to passenger vehicles
- 17 of the first division or motor vehicles of the second division

- 19 Section shall expire according to the multi-year procedure
- 20 established by Section 3-414.1 of this Code.
- 21 (b) The design and color of the plates shall be wholly

within the discretion of the Secretary of State, except that the phrase "Reach* Teach* Play" shall be on the plates. The plates are not required to designate "Land of Lincoln" as prescribed in subsection (b) of Section 3-412 of this Code. The Secretary may, in his or her discretion, allow the plates to be issued as vanity or personalized plates in accordance with Section 3-405.1 of this Code. The Secretary shall prescribe stickers or decals as provided under Section 3-412 of this Code.

(c) An applicant shall be charged a \$55 fee for original issuance in addition to the appropriate registration fee, if applicable. Of this fee, \$40 shall be deposited into the Ravinia Reach*Teach*Play Fund and \$15 shall be deposited into the Secretary of State Special License Plate Fund. For each registration renewal period, a \$42 fee, in addition to the appropriate registration fee, shall be charged. Of this fee, \$40 shall be deposited into the Ravinia Reach* Teach* Play Fund and \$2 shall be deposited into the Secretary of State Special License Plate Fund.

(d) The Ravinia Reach*Teach*Play Fund is created as a special fund in the State treasury. All moneys in the Ravinia Reach* Teach* Play Fund shall be paid, subject to appropriation by the General Assembly and approval by the Secretary, as grants to the Ravinia Festival Association for its Reach* Teach* Play music education programs.

Section 99. Effective date. This Act takes effect upon
